**Poison Creek**, Malheur NF, USFS. Ten miles southeast of Seneca, OR. Timber and grass. Active fire behavior with short crown runs, running and spotting. Area, road and trail closures in effect.

**Sand**, Malheur NF, USFS. Five miles southeast of Izee, OR. Timber and grass. Active fire behavior with short crown runs, running and spotting. Area, road and trail closures in effect.

**Crazy Creek**, Ochoco NF, USFS. CIMT (SW Team 5). Sixteen miles northeast of Paulina, OR. Short grass, brush and timber. Active fire behavior with spotting, running and torching. Numerous residences and sage-grouse habitat threatened. Evacuations, area, road and trail closures in effect.

**Diamond Complex (4 fires)**, Umpqua NF, USFS. CIMT (NR Team 3). CIMT is also managing the Middle Fork fire. Eighteen miles southwest of Chemult, OR. Brush and timber. Moderate fire behavior with flanking, backing and single tree torching. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

**Middle Fork**, Crater Lake NP, NPS. Fourteen miles northeast of Union Creek, OR. Timber and brush. Moderate fire behavior with backing, creeping and smoldering. Structures threatened. Trail closures in effect.

**Lane 1**, East Lane Unit, ODF. CIMT (NC State Team 1). IMT is also managing the Adam Mountain fire. Fifteen miles southeast of Springfield, OR. Timber and light slash. Active fire behavior with uphill runs, group torching and backing. Structures threatened. Area and road closures in effect.

Adam Mountain, Umpqua NF, USFS. Six miles southeast of Dorena, OR. Timber and light slash. Active fire behavior with group torching, uphill runs and backing. Numerous structures, communication and energy infrastructure threatened. Area, road and trail closures in effect.

**Willamette Complex (4 fires),** Willamette NF, USFS. CIMT (RM Team 1). CIMT (CA Team 13) mobilizing. IMT is also managing the Ore fire. Four miles northeast of Oakridge, OR. Brush and timber. Minimal fire behavior with backing, torching and spotting. Community of High Prairie and infrastructure threatened. Area, road and trail closures in effect. **Ore**, Willamette NF, USFS. Seven miles northeast of Blue River, OR. Brush and timber. Active fire behavior with backing, spotting and torching. Structures threatened. Area, road and trail closures in effect.

**Retreat**, Southeast Region, Washington DNR. CIMT (NR Team 1). CIMT (CA Team 14) mobilizing. Started on private land 14 miles southeast of Naches, WA. Short grass and timber. Active fire behavior with flanking, backing and single tree torching. Numerous structures, communication and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

**Homestead Complex (6 Fires)**, Umpqua NF, USFS. Transfer of command from CIMT (GB Team 5) to CIMT (NW Team 8) will occur today. Thirty miles northeast of Glide, OR. Timber and brush. Moderate fire behavior with backing, flanking and isolated torching. Area, road and trail closures in effect.

**Microwave Tower**, The Dalles Unit, Oregon DOF. CIMT (NR Team 2). IMT is also managing the Whiskey Creek fire. Five miles southwest of Mosier, OR. Grass and timber. Minimal fire behavior with creeping and smoldering. Numerous structures threatened. Evacuations, area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

**Whisky Creek**, Mt. Hood NF, USFS. Six miles southeast of Cascade Locks, OR. Timber. Moderate fire behavior with isolated torching, backing and creeping. Area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

**Cougar Creek,** Southeast Region, Washington DNR. CIMT (NW Team 12). Twenty-three miles southwest of Asotin, WA. Timber and brush. Minimal fire behavior with smoldering, creeping and flanking. Numerous structures threatened. Evacuations, area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

**Red**, Deschutes NF, USFS. CIMT (EA Team 1). IMT is also managing the Wickiup fire. Eighteen miles west of Crescent, OR. Timber. Active fire behavior with backing, creeping and single tree torching. Numerous structures threatened. Area, road and trail closures in effect.

**Wickiup**, Deschutes NF, USFS. Eight miles west of La Pine, OR. Timber. Minimal fire behavior. Area, road and trail closures in effect. Last report unless significant activity occurs.

**Battle Mountain Complex (2 fires)**, Pendleton Unit, Oregon DOF. IMT 1 (ODF Team 1) and CIMT (SW Team 3). Eight miles north of Ukiah, OR. Short grass, brush and timber. Moderate fire behavior with creeping, flanking and single tree torching. Numerous structures threatened. Evacuations, area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

**Lone Rock**, Prineville District, BLM. CIMT (SW Team 2). IMT is also managing the Courtrock fire. Started on county land 10 miles southeast of Condon, OR. Timber and tall grass. Minimal fire behavior with smoldering.

**Courtrock**, Fossil Unit, ODF. Seven miles south of Monument, OR. Timber and brush. Minimal fire behavior with creeping and smoldering. Numerous structures threatened. Area and road closures in effect.

**Swawilla I**, Colville Agency, BIA. CIMT (SA Team 2). Ten miles southwest of Keller, WA. Tall grass, brush and timber. Minimal fire behavior with flanking, backing and single tree torching. Numerous residences threatened. Evacuations, area, road and trail closures in effect.

**Durkee**, Vale District, BLM. Transfer of command from CIMT (SA Team 3) back to the local unit will occur tomorrow. Started on private land one mile west of Durkee, OR. Short grass and timber. Moderate fire behavior with flanking, backing and smoldering. Structures, infrastructure and sage-grouse habitat threatened. Evacuations, area and road closures in effect. Reduction in acreage due to more accurate mapping.

**Badland Complex**, Vale District, BLM. Three miles northeast of Durkee, OR. Brush and timber. Minimal fire behavior with creeping, single tree torching and smoldering. Structures, energy, communication infrastructure

and sage-grouse habitat threatened. Area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

**Winding Waters Complex (2 fires)**, Wallowa Unit, ODF. Twenty-three miles east of Union, OR. Timber and brush. Minimal fire behavior. Area, road and trail closures in effect.

\* **Elk Lane**, Prineville District, BLM. Six miles west of Madras, OR. Brush, grass and timber. Extreme fire behavior with wind-driven runs, spotting and flanking. Numerous structures threatened. Evacuations, area and road closures in effect.

\* **Salmon Creek**, Northeast Region, Washington DNR. Started on private land three miles southeast of Conconully, WA. Grass, brush and timber. Active fire behavior with creeping, isolated torching and smoldering. Community of Conconully threatened. Road, area and trail closures in effect.

\* **Soldier Creek**, Vale District, BLM. Sixteen miles southwest of Jordan Valley, OR. Grass and brush. Extreme fire behavior with wind-driven runs, running and flanking. Sage-grouse habitat threatened.

\* **Porcupine**, Burns District, BLM. Thirty-five miles southeast of Burns, OR. Grass, brush and timber. Extreme fire behavior with running, torching and creeping.

\* **Town Gulch**, Wallowa-Whitman NF, USFS. Eight miles north of Richland, OR. Timber. Active fire behavior with running, torching and spotting. Area, road and trail closures in effect.

\* **Bennett**, Prineville District, BLM. Started on RFPA land three miles northeast of Antelope, OR. Brush and grass. Active fire behavior with wind-driven and uphill runs. Structures threatened.

**Cliff Mountain**, Wallowa-Whitman NF, USFS. Twenty-five miles east of Joseph, OR. Grass, brush and timber. Minimal fire behavior with smoldering. Energy infrastructure threatened. Area closure in effect. Precipitation occurred over the fire area yesterday.

# **Predictive Services Discussion:**

Breezy and dry southwest sustained winds of 12-25 mph with gusts 25-35 mph amid relative humidity of 5-20% and above normal temperatures will develop across eastern Oregon, northern California, the northern Great Basin, southwest Montana, and western Wyoming. Areas of elevated to critical conditions are expected, with a period of dry, northwesterly winds likely after midnight across far northwest California and southwest Oregon. Dry, northerly winds are expected in the Okanogan Valley today and tonight, as well. Very dry conditions will continue in interior California, with poor overnight recovery of 20-40% for mid-slopes and ridges that will extend into eastern Oregon and much of the Great Basin. Isolated to scattered mainly wet thunderstorms are forecast near and east of the Divide in the Rockies from Montana south to Colorado and much of Arizona, while few thunderstorms are expected in New Mexico tomorrow. Isolated mixed wet and dry thunderstorms may develop on the western fringe of the moisture in portions of southeast Idaho, Utah, and western Wyoming with new ignitions likely.

Heavy rain and extensive, possibly catastrophic, flooding will continue in much of eastern Georgia and the Carolinas due to Tropical Storm Debby. Dry and hot southerly flow will continue the southern Plains with winds of 10-20 mph gusting to 20-30 mph amid minimum relative humidity of 10-25%. Otherwise, scattered showers and thunderstorms are likely in the northern Plains, Great Lakes, and Northeast. Strong, downslope Chinook winds will continue in the southeast Interior of Alaska with temperatures well into the 80s.
