Pioneer, Southeast Region, Washington DNR. CIMT (CA Team 15). IMT is also managing the Easy fire. Started on private land 10 miles southeast of Stehekin, WA. Timber and grass. Active fire behavior with uphill runs, flanking and backing. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Easy, Okanogan-Wenatchee NF, USFS. Seventeen miles west of Mazama, WA. Timber and brush. Active fire behavior with uphill runs, backing and spotting. Structures threatened. Area, road and trail closures in effect.

Diamond Complex (4 fires), Umpqua NF, USFS. CIMT (NR Team 3). CIMT is also managing the Middle Fork fire. Eighteen miles southwest of Chemult, OR. Brush and timber. Active fire behavior with flanking, backing and torching. Numerous structures and infrastructure threatened. Evacuations, area, road and trail closures in effect.

Middle Fork, Crater Lake NP, NPS. Fourteen miles northeast of Union Creek, OR. Brush and timber. Active fire behavior with flanking, backing and short-range spotting. Structures threatened. Trail closures in effect.

Crazy Creek, Ochoco NF, USFS. CIMT (SW Team 5). CIMT (CA Team 1) mobilizing. Sixteen miles northeast of Paulina, OR. Grass, brush and timber. Active fire behavior with flanking, group torching and spotting. Numerous residences and sage-grouse habitat threatened. Evacuations, area, road and trail closures in effect.

Falls, Malheur NF, USFS. CIMT (AK Team 1). CMIT (NW Team 2) mobilizing. IMT is also managing the Telephone, Poison Creek, and Sand fires. Twenty-six miles northwest of Burns, OR. Timber and grass. Active fire behavior with short crown runs, running and spotting. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Telephone, Malheur NF, USFS. Sixteen miles northeast of Burns, OR. Timber and grass. Active fire behavior with short crown runs, running and spotting. Numerous structures and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

Poison Creek, Malheur NF, USFS. Ten miles southeast of Seneca, OR. Timber and grass. Active fire behavior with short crown runs, running and spotting. Area, road and trail closures in effect.

Sand, Malheur NF, USFS. Five miles southeast of Izee, OR. Timber and grass. Active fire behavior with short crown runs, running and spotting. Area, road and trail closures in effect.

Lane 1, East Lane Unit, ODF. CIMT (NC State Team 1). Includes the acreage from the previously reported Adam Mountain fire. Fifteen miles southeast of Springfield, OR. Timber and light slash. Active fire behavior with uphill runs, torching and backing. Structures threatened. Area and road closures in effect.

Willamette Complex (4 fires), Willamette NF, USFS. Transfer of command from CIMT (RM Team 1) to CIMT (CA Team 13) will occur tomorrow. CMIT (AK Team 3) mobilizing. IMT is also managing the Ore fire. Four miles northeast of Oakridge, OR. Brush and timber. Active fire behavior with backing, torching and spotting. Infrastructure threatened. Area, road and trail closures in effect.

Ore, Willamette NF, USFS. Seven miles northeast of Blue River, OR. Brush and timber. Active fire behavior with backing, torching and spotting. Structures threatened. Area, road and trail closures in effect.

Retreat, Southeast Region, Washington DNR. Transfer of command from CIMT (NR Team 1) to CIMT (CA Team 14) will occur tomorrow. Started on private land 14 miles southeast of Naches, WA. Grass and timber. Active fire behavior with flanking, group torching and short-range spotting. Numerous structures, communication and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

Homestead Complex (6 Fires), Umpqua NF, USFS. CIMT (NW Team 8). Thirty miles northeast of Glide, OR. Timber and brush. Active fire behavior with flanking, backing and torching. Area, road and trail closures in effect.

Microwave Tower, The Dalles Unit, Oregon DOF. CIMT (NR Team 2). IMT is also managing the Whiskey Creek fire. Five miles southwest of Mosier, OR. Grass and timber. Minimal fire behavior with creeping and smoldering. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Whisky Creek, Mt. Hood NF, USFS. Six miles southeast of Cascade Locks, OR. Timber. Moderate fire behavior with single tree torching, backing and creeping. Area, road and trail closures in effect.

Cougar Creek, Southeast Region, Washington DNR. CIMT (NW Team 12). Twenty-three miles southwest of Asotin, WA. Timber and brush. Minimal fire behavior with smoldering, creeping and flanking. Numerous structures threatened. Evacuations, area, road and trail closures in effect. Reduction in acreage due to more accurate mapping.

Red, Deschutes NF, USFS. Transfer of command from CIMT (EA Team 1) back to local unit will occur tomorrow. Eighteen miles west of Crescent, OR. Timber. Active fire behavior with backing, creeping and single tree torching. Numerous structures threatened. Area, road and trail closures in effect.

Battle Mountain Complex (2 fires), Pendleton Unit, Oregon DOF. Transfer of command from IMT 1 (ODF Team 1) to CIMT (SW Team 3) will occur tomorrow. Eight miles north of Ukiah, OR. Grass, brush and timber. Active fire behavior with spotting, uphill runs and single tree torching. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Lone Rock, Prineville District, BLM. CIMT (SW Team 2). IMT is also managing the Courtrock fire. Started on county land 10 miles southeast of Condon, OR. Timber and grass. Minimal fire behavior with smoldering.

Courtrock, Fossil Unit, ODF. Seven miles south of Monument, OR. Timber and brush. Moderate fire behavior with single tree torching, short-range spotting and smoldering. Numerous structures threatened. Area and road closures in effect.

Swawilla I, Colville Agency, BIA. CIMT (SA Team 2). Ten miles southwest of Keller, WA. Grass, brush and timber. Minimal fire behavior with flanking, backing and single tree torching. Numerous residences threatened. Evacuations, area, road and trail closures in effect.

Durkee, Vale District, BLM. Transfer of command from CIMT (SA Team 3) back to the local unit will occur today. Started on private land one mile west of Durkee, OR. Grass and timber. Minimal fire behavior. Structures, infrastructure and sage-grouse habitat threatened. Evacuations, area and road closures in effect.

* Williams Mine, Gifford Pinchot NF, USFS. Four miles northwest of Trout Lake, WA. Timber and medium slash. Extreme fire behavior with running, group torching and long-range spotting. Community of Trout Lake threatened. Evacuations, area, road and trail closures in effect.

Soldier Creek, Vale District, BLM. Sixteen miles southwest of Jordan Valley, OR. Grass and brush. Extreme fire behavior with wind-driven runs, running and flanking. Sage-grouse habitat threatened.

Town Gulch, Wallowa-Whitman NF, USFS. Eight miles north of Richland, OR. Timber. Extreme fire behavior with uphill runs, flanking and backing. Area, road and trail closures in effect.

Elk Lane, Prineville District, BLM. Six miles west of Madras, OR. Brush, grass and timber. Extreme fire behavior with wind-driven runs, spotting and flanking. Numerous structures threatened. Evacuations, area and road closures in effect.

* Warner Peak, Sheldon-Hart Mountain NWR, FWS. Thirty-two miles northeast of Lakeview, OR. Brush and grass. Active fire behavior with wind-driven runs, torching and flanking. Structures threatened. Area and road closures in effect.

Badland Complex, Vale District, BLM. Three miles northeast of Durkee, OR. Brush and timber. Minimal fire behavior with smoldering. Structures and sage-grouse habitat threatened.

Winding Waters Complex (2 fires), Wallowa Unit, ODF. Twenty-three miles east of Union, OR. Timber and brush. Minimal fire behavior. Area, road and trail closures in effect.

Cliff Mountain, Wallowa-Whitman NF, USFS. Twenty-five miles east of Joseph, OR. Grass, brush and timber. Minimal fire behavior with smoldering. Energy infrastructure threatened. Area closure in effect.

Bennett, Prineville District, BLM. Started on RFPA land three miles northeast of Antelope, OR. Brush and grass. Minimal fire behavior with smoldering and creeping.

Salmon Creek, Northeast Region, Washington DNR. Started on private land three miles southeast of Conconully, WA. Grass, brush and timber. No new information.

Predictive Services Discussion:

Very low relative humidity of 5-20% will continue across much of the Inland Northwest, California, Great Basin, and southwest Wyoming, with poor overnight recovery of 20-40% for mid-slopes and ridges. Dry conditions, low relative humidity, and hot temperatures are likely across much of New Mexico into the southern Plains, as well. Winds will be lighter overall with westerly winds generally 10-15 mph across the West with southeasterly winds on the southern Plains. However, stronger westerly sustained winds of 15-25 mph with gusts 30-45 mph will develop in the Upper Snake River Plain into western Wyoming for elevated to locally critical conditions ahead of a cold front. Gusty northerly winds of 10-20 mph are also likely in the Okanogan Valley of Washington, spreading into portions of the Columbia Basin.

Scattered wet thunderstorms will develop near and east of the Divide in Montana into eastern Wyoming and the northern Plains. Isolated to scattered mainly wet thunderstorms will develop in much of Arizona, western New Mexico, and the Colorado Rockies, although drier storms are possible in eastern Utah. Heavy rain and extensive flooding will continue in the eastern Carolinas due to Tropical Storm Debby, with showers and thunderstorms spreading north into the Mid-Atlantic and southern New England. Strong southerly Chinook winds gusting to 50 mph will continue north of the Alaska Range for the eastern Interior, with well above normal temperatures.
