Sixty-six fireline management personnel from Australia and New Zealand are assigned to support large fires in the Northwest Area.

Pioneer, Southeast Region, Washington DNR. CIMT (CA Team 15). IMT is also managing the Easy fire. Started on private land 10 miles southeast of Stehekin, WA. Timber and grass. Active fire behavior with uphill runs, group torching and short-range spotting. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Easy, Okanogan-Wenatchee NF, USFS. Seventeen miles west of Mazama, WA. Timber and brush. Active fire behavior with uphill runs, backing and single tree torching. Structures threatened. Area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

Diamond Complex (8 fires), Umpqua NF, USFS. CIMT (NR Team 3). IMT is also managing the Middle Fork fire. Eighteen miles southwest of Chemult, OR. Timber. Active fire behavior with flanking, torching and short-range spotting. Structures and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

Middle Fork, Crater Lake NP, NPS. Fourteen miles northeast of Union Creek, OR. Timber and brush. Active fire behavior with group torching, short-range spotting and flanking. Structures threatened. Trail closures in effect.

Willamette Complex (4 fires), Willamette NF, USFS. CIMT (AK Team 3) and CIMT (CA Team 13). IMT is also managing the Ore fire. Eight miles southeast of Oakridge, OR. Brush and timber. Active fire behavior with flanking, group torching and spotting. Infrastructure threatened. Area, road and trail closures in effect.

Ore, Willamette NF, USFS. Seven miles northeast of Blue River, OR. Brush and timber. Active fire behavior with uphill runs, torching and spotting. Structures threatened. Area, road and trail closures in effect.

Crazy Creek, Ochoco NF, USFS. Transfer of command from CIMT (SW Team 5) to CIMT (CA Team 1) will occur today. Sixteen miles northeast of Paulina, OR. Grass, brush and timber. Active fire behavior with flanking, group torching and spotting. Numerous residences and sage-grouse habitat threatened. Evacuations, area, road and trail closures in effect.

Lane 1, East Lane Unit, ODF. Transfer of command from CIMT (NC State Team 1) to IMT1 (ODF Team 1) will occur today. Fifteen miles southeast of Springfield, OR. Timber and light slash. Active fire behavior with group torching, uphill runs and spotting. Structures threatened. Evacuations, area and road closures in effect.

Cougar Creek, Southeast Region, Washington DNR. CIMT (NW Team 12). Twenty-three miles southwest of Asotin, WA. Timber and brush. Minimal fire behavior with smoldering, creeping and flanking. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Retreat, Southeast Region, Washington DNR. CIMT (CA Team 14). Started on private land 14 miles southeast of Naches, WA. Grass, brush and timber. Active fire behavior with creeping, backing and isolated torching. Numerous structures, communication and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

Sandstone, Mt. Hood NF, USFS. CIMT (NR Team 2). IMT is also managing the Whisky Creek fire. Nine miles southwest of Ripplebrook, OR. Timber, medium slash and chaparral. Moderate fire behavior with single tree torching, backing and creeping. Area, road and trail closures in effect.

Whisky Creek, Mt. Hood NF, USFS. Six miles southeast of Cascade Locks, OR. Timber. Moderate fire behavior with single tree torching, backing and creeping. Area, road and trail closures in effect.

Homestead Complex (6 Fires), Umpqua NF, USFS. CIMT (NW Team 8). Thirty miles northeast of Glide, OR. Timber and brush. Active fire behavior with flanking, short-range spotting and backing. Structures threatened. Area, road and trail closures in effect.

Falls, Malheur NF, USFS. Transfer of command from CIMT (AK Team 1) to CIMT (NW Team 2) will occur today. IMT is also managing the Telephone and Sand fires. Twenty-six miles northwest of Burns, OR. Timber and grass. Active fire behavior with short crown runs, running and spotting. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Telephone, Malheur NF, USFS. Sixteen miles northeast of Burns, OR. Timber and grass. Active fire behavior with short crown runs, running and spotting. Numerous structures and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

Sand, Malheur NF, USFS. Five miles southeast of Izee, OR. Timber and grass. Active fire behavior with short crown runs, running and spotting. Area, road and trail closures.

Battle Mountain Complex (2 fires), Pendleton Unit, Oregon DOF. CIMT (SW Team 3). Eight miles north of Ukiah, OR. Grass, hardwood litter and timber. Active fire behavior with uphill runs, torching and spotting. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Lone Rock, Prineville District, BLM. CIMT (SW Team 2). IMT is also managing the Courtrock fire. Started on county land 10 miles southeast of Condon, OR. Timber and grass. Minimal fire behavior with smoldering.

Courtrock, Fossil Unit, ODF. Seven miles south of Monument, OR. Timber and brush. Minimal fire behavior with creeping and smoldering. Area and road closures in effect.

Town Gulch, Wallowa-Whitman NF, USFS. CIMT (SA Team 2). Eight miles north of Richland, OR. Timber and grass. Active fire behavior with uphill runs, flanking and backing. Several communities threatened. Evacuations, area, road and trail closures in effect.

Williams Mine, Gifford Pinchot NF, USFS. CIMT (NW Team 13). Four miles northwest of Trout Lake, WA. Timber, medium slash and chaparral. Extreme fire behavior with running, group torching and short-range spotting. Community of Trout Lake threatened. Evacuations, area, road and trail closures in effect.

Warner Peak, Sheldon-Hart Mountain NWR, FWS. CIMT (SW Team 1) mobilizing. Thirty-two miles northeast of Lakeview, OR. Brush and grass. Active fire behavior with running, spotting and torching. Structures threatened. Area and road closures in effect.

Red, Deschutes NF, USFS. Eighteen miles west of Crescent, OR. Timber. Minimal fire behavior with creeping, single tree torching and smoldering. Numerous structures threatened. Area, road and trail closures in effect.

Elk Lane, Prineville District, BLM. Six miles west of Madras, OR. Brush, grass and timber. Minimal fire behavior with creeping and smoldering. Numerous structures threatened. Area and road closures in effect.

Durkee, Vale District, BLM. Started on private land one mile west of Durkee, OR. Grass and timber. Minimal fire behavior. Structures and sage-grouse habitat threatened.

Soldier Creek, Vale District, BLM. Sixteen miles southwest of Jordan Valley, OR. Grass and brush. Minimal fire behavior. Sage-grouse habitat threatened. Last report unless significant activity occurs.

Porcupine, Burns District, BLM. Thirty-five miles southeast of Burns, OR. Grass, brush and timber. Minimal fire behavior with creeping and smoldering. Sage-grouse habitat threatened.

Cliff Mountain, Wallowa-Whitman NF, USFS. Twenty-five miles east of Joseph, OR. Grass, brush and timber. Minimal fire behavior with smoldering. Energy infrastructure threatened. Area closure in effect.

Swawilla I, Colville Agency, BIA. Ten miles southwest of Keller, WA. Grass, brush and timber. No new information.

Salmon Creek, Northeast Region, Washington DNR. Started on private land three miles southeast of Conconully, WA. Grass, brush and timber. No new information.

Paddock, Boise District, BLM. Twenty-one miles northeast of Payette, ID. Grass and brush. Extreme fire behavior with short-range spotting, uphill and wind-driven runs. Numerous structures and sage-grouse habitat threatened. Evacuations and road closures in effect. Reduction in acreage due to more accurate mapping.

* **Middle Fork Complex (3 fires)**, Boise NF, USFS. CIMT (NR Team 5). Includes the previously reported Anderson, Bulldog and Nellie fires. Nine miles east of Garden Valley, ID. Timber. Active fire behavior with uphill runs, group torching and flanking. Numerous structures threatened. Area, road and trail closures in effect.

Boulder, Boise NF, USFS. Transfer of command from CIMT (GB Team 7) to CIMT (GB Team 2) will occur today. IMT is also managing the Wapiti, Bulltrout, Wolf Creek, Snag and Dollar fires. Nine miles southwest of Cascade, ID. Timber and brush. Active fire behavior with isolated torching, spotting and flanking. Structures and communication infrastructure threatened. Area, road and trail closures in effect.

Wapiti, Boise NF, USFS. Fourteen miles west of Stanley, ID. Timber. Active fire behavior with group torching, spotting and flanking. Structures threatened. Evacuations, area, road and trail closures in effect.

Bulltrout, Boise NF, USFS. Fifteen miles northwest of Stanley, ID. Timber and brush. Minimal fire behavior with creeping and smoldering. Structures threatened. Area, road and trail closures in effect.

Wolf Creek, Payette NF, USFS. Eleven miles northwest of Cascade, ID. Timber and brush. Moderate fire behavior with torching, backing and flanking. Structures threatened. Area, road and trail closures in effect.

Snag, Boise NF, USFS. Ten miles east of Cascade, ID. Timber. Active fire behavior with crowning, running and spotting. Residences threatened. Area, road and trail closures in effect.

Dollar, Boise NF, USFS. Eighteen miles northeast of Cascade, ID. Timber and grass. Active fire behavior with group torching, spotting and flanking. Residences threatened. Area, road and trail closures in effect.

Flat, Southwest Area, Idaho Department of Lands. Eleven miles north of Idaho City, ID. Timber. Moderate fire behavior with group torching, flanking and backing. Structures threatened.

Limepoint, Payette NF, USFS. CIMT (SA Team 1) and CMIT (GB Team 4). IMT is also managing the Cliff Mountain fire in the Northwest Area. Three miles southwest of Cuprum, ID. Grass, brush and timber. Minimal fire behavior with creeping and torching. Structures, energy and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

Leeds Creek, Bridger-Teton NF, USFS. Eighteen miles southwest of Dubois, WY. Heavy slash and timber. Minimal fire behavior with creeping, smoldering and isolated torching. Area, road and trail closure in effect.

* **Dove Creek**, Bear River Area, Utah DOF. Ten miles south of Dove Creek, UT. Grass and brush. Moderate fire behavior with running, wind-driven runs and torching. Residences and sage-grouse habitat threatened.

* **Paws Pocket**, Lake Mead National Recreation Area, NPS. Sixty miles south of St. George, UT. Brush and hardwood slash. Active fire behavior with running, creeping and torching. Structures threatened.

Stockade Canyon, Winnemucca District, BLM. Nineteen miles northwest of Gerlach, NV. Brush and timber. Moderate fire behavior with creeping, smoldering and backing. Structures and sage-grouse habitat threatened. Last report unless significant activity occurs.

Dry Fork, West Desert District, BLM. Ten miles southwest of Randolph, UT. Timber and brush. Minimal fire behavior.

Cox Pond, Arizona Strip District, BLM. Thirty-one miles south of St. George, UT. Grass, brush, and hardwood slash. Minimal fire behavior with smoldering. Last report unless significant activity occurs.

Predictive Services Discussion:

A persistent weather pattern will remain in place with continued above normal temperatures west of the Divide and continued low relative humidity of 5-20%, driest over central and northern California into the northern Great Basin. As troughing deepens over the Northwest coast, breezy westerly winds will expand in areal coverage over most of California, Nevada, and southern Idaho and strengthen to 15-25 mph with gusts to 35-40 mph. There will also be a return of breezy westerly winds to the Cascade gaps and Columbia Basin. Overnight recoveries will still be poor for the ridges and mid-slopes and elevated to locally critical conditions are likely to continue.

Monsoon showers and thunderstorms will become less widespread than previous days and will likely be most prevalent in Arizona and the southern Great Basin with fewer in New Mexico. Thunderstorm activity will likely continue to be wet and slow moving. Widespread shower and thunderstorm activity will also continue east of the Divide from southern Montana into Colorado, and potentially Oklahoma as well. Continued troughing and limited moisture over the Northwest coast will lead to a continued threat of isolated dry thunderstorms over eastern Oregon and central Idaho. The remnants of Debby will move out of the Northeast and drier conditions will prevail over the East Coast. Hot and dry conditions will continue over the Lower Mississippi Valley with locally breezy winds.
