153<sup>rd</sup> Airlift Wing (WY Air National Guard), 302<sup>nd</sup> Airlift Wing (CO Air Force Reserve), 146<sup>th</sup> Airlift Wing (CA Air National Guard), and 152<sup>nd</sup> Airlift Wing (NV Air National Guard).

Sixty fireline management personnel from Australia and New Zealand are assigned to support large fires in the Northwest Area.

**Williams Mine**, Gifford Pinchot NF, USFS. CIMT (NW Team 13). Four miles northwest of Trout Lake, WA. Brush, timber and heavy slash. Active fire behavior with spotting, group torching and running. Community of Trout Lake and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

**Town Gulch**, Wallowa-Whitman NF, USFS. CIMT (SA Team 2). Eight miles north of Richland, OR. Timber and grass. Moderate fire behavior with creeping, flanking and single tree torching. Several communities threatened. Evacuations, area, road and trail closures in effect. Reduction in acreage due to more accurate mapping.

**Diamond Complex (8 fires)**, Umpqua NF, USFS. CIMT (NR Team 3). IMT is also managing the Middle Fork fire. Eighteen miles southwest of Chemult, OR. Timber. Active fire behavior with flanking, backing and isolated torching. Structures and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

**Middle Fork**, Crater Lake NP, NPS. Fourteen miles northeast of Union Creek, OR. Timber and brush. Active fire behavior with short-range spotting, flanking and backing. Structures threatened. Trail closures in effect.

**Pioneer**, Southeast Region, Washington DNR. CIMT (CA Team 15). IMT is also managing the Easy fire. Started on private land 10 miles southeast of Stehekin, WA. Timber and grass. Active fire behavior with uphill runs, flanking and short-range spotting. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

**Easy**, Okanogan-Wenatchee NF, USFS. Seventeen miles west of Mazama, WA. Timber and brush. Active fire behavior with uphill runs, backing and single tree torching. Structures threatened. Area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

**Willamette Complex (4 fires)**, Willamette NF, USFS. CIMT (AK Team 3) and CIMT (CA Team 13). IMTs are also managing the Ore fire. Eight miles southeast of Oakridge, OR. Brush and timber. Moderate fire behavior with backing, creeping and flanking. Infrastructure threatened. Area, road and trail closures in effect.

**Ore**, Willamette NF, USFS. Seven miles northeast of Blue River, OR. Brush and timber. Active fire behavior with uphill runs, torching and short-range spotting. Structures threatened. Area, road and trail closures in effect.

**Warner Peak**, Sheldon-Hart Mountain NWR, FWS. CIMT (SW Team 1). Thirty-two miles northeast of Lakeview, OR. Brush and grass. Active fire behavior with wind-driven runs, flanking and short-range spotting. Structures, communication and sage-grouse habitat threatened. Area and road closures in effect.

**Lane 1**, East Lane Unit, ODF. IMT1 (ODF Team 1). Fifteen miles southeast of Springfield, OR. Timber, closed timber litter and light slash. Active fire behavior with uphill runs, torching and spotting. Structures, energy and communication infrastructure threatened. Evacuations, area and road closures in effect.

**Cougar Creek**, Southeast Region, Washington DNR. Transition from CIMT (NW Team 12) back to local unit will occur tomorrow. Twenty-three miles southwest of Asotin, WA. Timber and brush. Active fire behavior with smoldering, creeping and flanking. Numerous structures threatened. Evacuations, area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

**Crazy Creek**, Ochoco NF, USFS. CIMT (CA Team 1). Sixteen miles northeast of Paulina, OR. Grass, brush and timber. Active fire behavior with flanking, group torching and spotting. Numerous residences and sage-grouse habitat threatened. Evacuations, area, road and trail closures in effect.

**Falls**, Malheur NF, USFS. CIMT (NW Team 2). IMT is also managing the Telephone and Sand fires. Twenty-six miles northwest of Burns, OR. Timber and grass. Active fire behavior with flanking, isolated torching and short-range spotting. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

**Telephone**, Malheur NF, USFS. Sixteen miles northeast of Burns, OR. Timber and brush. Moderate fire behavior with flanking, backing and isolated torching. Numerous structures threatened. Evacuations, area, road and trail closures in effect. Precipitation occurred in the fire area yesterday.

**Sand**, Malheur NF, USFS. Five miles southeast of Izee, OR. Timber and grass. Active fire behavior with flanking, isolated torching and short-range spotting. Area, road and trail closures in effect.

**Retreat**, Southeast Region, Washington DNR. CIMT (CA Team 14). Started on private land 14 miles southeast of Naches, WA. Grass, brush and timber. Minimal fire behavior with creeping and smoldering. Numerous structures, communication and energy infrastructure threatened. Evacuations, area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

**Battle Mountain Complex (2 fires)**, Pendleton Unit, Oregon DOF. CIMT (SW Team 3). Eight miles north of Ukiah, OR. Grass, hardwood litter and timber. Moderate fire behavior with backing, creeping and smoldering. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

**Sandstone**, Mt. Hood NF, USFS. CIMT (NR Team 2). IMT is also managing the Whisky Creek fire. Nine miles southwest of Ripplebrook, OR. Timber, medium slash and chaparral. Moderate fire behavior with single tree torching, backing and creeping. Area, road and trail closures in effect.

**Whisky Creek**, Mt. Hood NF, USFS. Six miles southeast of Cascade Locks, OR. Timber. Moderate fire behavior with single tree torching, spotting and creeping. Energy infrastructure threatened. Area, road and trail closures in effect.

**Homestead Complex (6 Fires)**, Umpqua NF, USFS. CIMT (NW Team 8). Thirty miles northeast of Glide, OR. Timber and brush. Active fire behavior with flanking, backing and short-range spotting. Structures and communication infrastructure threatened. Area, road and trail closures in effect.

**Lone Rock**, Prineville District, BLM. Transfer of command from CIMT (SW Team 2) back to local unit will occur today. IMT is also managing the Courtrock fire. Started on county land 10 miles southeast of Condon, OR. Timber and grass. Minimal fire behavior with smoldering.

**Courtrock**, Fossil Unit, ODF. Seven miles south of Monument, OR. Timber and brush. Minimal fire behavior with creeping and smoldering. Area and road closures in effect.

\* **Dixon**, Umpqua NF, USFS. IMT 1 (ODF Team 2). Eighteen miles east of Canyonville, OR. Timber and slash. Active fire behavior with running, group torching and spotting. Numerous structures, energy and communication infrastructure threatened. Evacuations, area and road closures in effect.

**Red**, Deschutes NF, USFS. Eighteen miles west of Crescent, OR. Timber. Minimal fire behavior with creeping, single tree torching and smoldering. Numerous structures threatened. Area, road and trail closures in effect.

**Elk Lane**, Prineville District, BLM. Six miles west of Madras, OR. Brush, grass and timber. Minimal fire behavior. Numerous structures threatened. Road closures in effect.

**Porcupine**, Burns District, BLM. Thirty-five miles southeast of Burns, OR. Grass, brush and timber. Minimal fire behavior with smoldering. Sage-grouse habitat threatened. Last report unless significant activity occurs.

**Cliff Mountain**, Wallowa-Whitman NF, USFS. Twenty-five miles east of Joseph, OR. Grass, brush and timber. Minimal fire behavior with creeping and smoldering. Energy infrastructure threatened. Area closure in effect.

**Durkee**, Vale District, BLM. Started on private land one mile west of Durkee, OR. Grass and timber. Minimal fire behavior with smoldering. Structures and infrastructures threatened. Last report unless significant activity occurs.

\* **Road Nine**, Douglas County Fire Districts. Twelve miles northwest of Coulee City, WA. Brush and grass. Moderate fire behavior with smoldering. Structures threatened.

\* **Ruby**, North Cascades NP, NPS. Thirty-two miles northwest of Stehekin, WA. Timber and brush. Active fire behavior with short crown runs and group torching. Structures and energy infrastructure threatened. Area and trail closures.

**Dollar**, Boise NF, USFS. Eighteen miles northeast of Cascade, ID. Timber and grass. Active fire behavior with group torching, spotting and flanking. Residences threatened. Area, road and trail closures in effect.

**Limepoint**, Payette NF, USFS. CIMT (GB Team 4). IMT is also managing the Cliff Mountain fire in the Northwest Area. Three miles southwest of Cuprum, ID. Grass, brush and timber. ## **Predictive Services Discussion:**

Troughing will deepen over the West Coast while ridging shifts farther east into the Plains. Further cooling is expected west of the Divide bringing temperatures around seasonal normals, and even 3 to 6 degrees below normal west of the Cascades. Meanwhile, temperatures over the Southern Plains and Gulf Coast will soar to 5 to 10 degrees above normal. Temperatures in the Lower Mississippi Valley and Southern Plains will continue to rise near to above 100°F. Breezy northerly offshore winds are likely to continue for the Gulf Coast states and breezy southerly winds of 15-25 mph will continue for west Texas. These conditions will keep low humidity in place that will continue to enhance fire potential.

Monsoon activity will continue to remain active for Arizona, Utah, and Colorado. It will likely remain dry over southeast California and Nevada due to increasing westerly flow. Increasing moisture and instability from the trough may bring scattered showers and thunderstorms to portions of the Northwest, northern Great Basin, and across the Rockies. Storms will be fast moving so there may be a mix of wet and dry storms, so an increase in fire potential will be possible with increased lightning activity. Increasing moisture from the trough will lead to very dry conditions becoming a bit less widespread over the northern/western Great Basin into California, though RH will still be in the 8-25% range for the driest areas. Westerly winds are expected to strengthen and become more widespread for California, Nevada, and into southwest Idaho and Wyoming keeping elevated to critical fire weather conditions in place
