Williams Mine, Gifford Pinchot NF, USFS. CIMT (NW Team 13). Four miles northwest of Trout Lake, WA. Brush, timber and heavy slash. Active fire behavior with spotting, flanking and torching. Communities and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

Dixon, Umpqua NF, USFS. IMT 1 (ODF Team 2). Eighteen miles east of Canyonville, OR. Timber and slash. Active fire behavior with single tree torching, spotting and creeping. Numerous structures and infrastructure threatened. Evacuations, area road and trail closures in effect.

Diamond Complex (7 fires), Umpqua NF, USFS. CIMT (NR Team 3). CIMT (CA Team 4) mobilizing. IMT is also managing the Middle Fork fire. Eighteen miles southwest of Chemult, OR. Timber. Active fire behavior with flanking, backing and isolated torching. Structures and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

Middle Fork, Crater Lake NP, NPS. Fourteen miles northeast of Union Creek, OR. Timber and brush. Active fire behavior with short-range spotting, flanking and backing. Structures threatened. Area, road and trail closures in effect.

Warner Peak, Sheldon-Hart Mountain NWR, FWS. CIMT (SW Team 1). Thirty-two miles northeast of Lakeview, OR. Brush and grass. Active fire behavior with uphill runs, torching and short-range spotting. Structures and communication infrastructure threatened. Evacuations, area and road closures in effect. Sage-grouse habitat threatened.

Willamette Complex (4 fires), Willamette NF, USFS. CIMT (AK Team 3) and CIMT (CA Team 13). IMTs are also managing the Ore fire. Eight miles southeast of Oakridge, OR. Brush and timber. Moderate fire behavior with backing, creeping and isolated torching. Numerous residences threatened. Area, road and trail closures in effect.

Ore, Willamette NF, USFS. Seven miles northeast of Blue River, OR. Brush and timber. Active fire behavior with uphill runs, short-range spotting and backing. Structures threatened. Area, road and trail closures in effect.

Retreat, Southeast Region, Washington DNR. CIMT (CA Team 14). Started on private land 14 miles southeast of Naches, WA. Grass, brush and timber. Minimal fire behavior with creeping and smoldering. Numerous structures and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

Pioneer, Southeast Region, Washington DNR. CIMT (CA Team 15). CIMT (NW Team 3) mobilizing. IMT is also managing the Easy fire. Started on private land 10 miles southeast of Stehekin, WA. Timber and grass. Minimal fire behavior with flanking, backing and creeping. Numerous structures threatened. Evacuations, area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

Easy, Okanogan-Wenatchee NF, USFS. Seventeen miles west of Mazama, WA. Timber and brush. Minimal fire behavior with backing, creeping and smoldering. Structures threatened. Area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

Sandstone, Mt. Hood NF, USFS. CIMT (NR Team 2). CIMT (NW Team 10) is mobilizing. IMT is also managing the Whisky Creek fire. Nine miles southwest of Ripplebrook, OR. Timber and chaparral. Moderate fire behavior with single tree torching, backing and creeping. Area, road and trail closures in effect.

Whisky Creek, Mt. Hood NF, USFS. Six miles southeast of Cascade Locks, OR. Timber. Minimal fire behavior with creeping and smoldering. Area, road and trail closures in effect.

Falls, Malheur NF, USFS. CIMT (NW Team 2). IMT is also managing the Telephone fire. Twenty-six miles northwest of Burns, OR. Timber and grass. Moderate fire behavior with backing, creeping and isolated torching. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Telephone, Malheur NF, USFS. Sixteen miles northeast of Burns, OR. Timber and brush. Minimal fire behavior with backing, creeping and isolated torching. Numerous structures and sage-grouse habitat threatened. Evacuations, area, road and trail closures in effect.

Crazy Creek, Ochoco NF, USFS. CIMT (CA Team 1). Sixteen miles northeast of Paulina, OR. Grass, brush and timber. Moderate fire behavior with backing, creeping and smoldering. Residences and sage-grouse habitat threatened. Evacuations, area, road and trail closures in effect.

Homestead Complex (6 Fires), Umpqua NF, USFS. CIMT (NW Team 8). CIMT (NR Team 6) is mobilizing. Thirty miles northeast of Glide, OR. Timber, closed timber litter and brush. Active fire behavior with flanking, backing and short-range spotting. Structures and communication infrastructure threatened. Area, road and trail closures in effect.

Battle Mountain Complex (2 fires), Pendleton Unit, Oregon DOF. CIMT (SW Team 3). Eight miles north of Ukiah, OR. Grass, hardwood litter and timber. Minimal fire behavior with creeping and smoldering. Numerous structures threatened. Area, road and trail closures in effect.

Town Gulch, Wallowa-Whitman NF, USFS. CIMT (SA Team 2). Eight miles north of Richland, OR. Timber and grass. Moderate fire behavior with creeping and flanking. Several communities threatened. Evacuations, area, road and trail closures in effect.

Cougar Creek, Southeast Region, Washington DNR. Twenty-three miles southwest of Asotin, WA. Timber and brush. Minimal fire behavior with smoldering. Area, road and trail closures in effect.

Lane 1, East Lane Unit, ODF. IMT 1 (ODF Team 1). Fifteen miles southeast of Springfield, OR. Timber, closed timber litter and light slash. Active fire behavior with uphill runs, torching and spotting. Structures, energy and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

Red, Deschutes NF, USFS. Eighteen miles west of Crescent, OR. Timber. Minimal fire behavior with backing, creeping and smoldering. Numerous structures threatened. Area, road and trail closures in effect.

Cliff Mountain, Wallowa-Whitman NF, USFS. Twenty-five miles east of Joseph, OR. Grass, brush and timber. Minimal fire behavior with smoldering. Area closure in effect.

Ruby, North Cascades NP, NPS. Thirty-two miles northwest of Stehekin, WA. Timber and brush. Active fire behavior with smoldering and short-range spotting. Structures and threatened. Area and trail closures in effect.

Courtrock, Fossil Unit, ODF. Seven miles south of Monument, OR. Timber and brush. Minimal fire behavior with creeping and smoldering. Area and road closures in effect. No new information.

Lone Rock, Prineville District, BLM. Started on county land 10 miles southeast of Condon, OR. Timber and grass. Minimal fire behavior with smoldering. No new information. Last report unless new information is received.

Predictive Services Discussion:

Another shortwave trough will move across the northern West Coast on Thursday that will bring another round of scattered mixed wet/dry thunderstorms to northeast California into eastern Oregon and Washington, Idaho, and western Montana and Wyoming. Confidence is moderate/high that storms will be on the drier side overall as moisture is shallow and storm motion is fast, especially in Idaho. As a result, the increased lightning activity will bring back high-risk significant fire potential for Oregon into Idaho. Wet weather is expected across the central and northern Plains through the upper Midwest with significant precipitation likely. Dry southwesterly flow over the Southwest and southern Great Basin will decrease monsoon activity, keeping any thunderstorms mostly isolated to New Mexico.

Very dry conditions with low humidity are expected to continue for the interior of Southern California, western Arizona, Nevada, and Utah with humidity as low as 5-20%, along with areas of poor overnight recovery. Areas of breezy conditions are also expected to continue in these areas and will likely be stronger than Wednesday. High-risk significant fire potential will return for portions of Nevada. Hot, dry, and breezy conditions will continue for Texas and Oklahoma keeping fire potential elevated. Scattered afternoon thunderstorm coverage will continue for the Lower Mississippi Valley but the moisture from the sea breeze will continue to keep fire potential moderate.
