Four MAFFS C-130 airtankers and support personnel have been deployed to Port Hueneme, CA to support wildland fire operations nationally. Their respective units are as follows: 153rd Airlift Wing (WY Air National Guard), 302nd Airlift Wing (CO Air Force Reserve), 146th Airlift Wing (CA Air National Guard), and 152nd Airlift Wing (NV Air National Guard).

Sixty fireline management personnel from Australia and New Zealand are assigned to support large fires in the Northwest Area.

Two hundred forty-five soldiers from the 14th Brigade Engineer Battalion and the 1st Battalion, 17th Infantry Regiment based out of Joint Base Lewis McChord (JBLM) are deployed in support of wildland fire operations on the Boise National Forest. NIMO (Team 2) is assigned to support the military contingent.

Diamond Complex (6 fires), Umpqua NF, USFS. Transfer of command from CIMT (NR Team 3) to CIMT (CA Team 4) will occur today. IMT is also managing the Middle Fork fire. Eighteen miles southwest of Chemult, OR. Timber. Moderate fire behavior with flanking, backing and isolated torching. Structures and energy infrastructure threatened. Evacuations, area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

Middle Fork, Crater Lake NP, NPS. Fourteen miles northeast of Union Creek, OR. Timber and brush. Moderate fire behavior with torching, creeping and backing. Structures threatened. Area, road and trail closures in effect.

Willamette Complex (4 fires), Willamette NF, USFS. CIMT (AK Team 3) and CIMT (CA Team 13). CIMT (NW Team 7) is mobilizing. IMTs are also managing the Ore fire. Eight miles southeast of Oakridge, OR. Brush and timber. Moderate fire behavior with backing, creeping and isolated torching. Numerous residences threatened. Area, road and trail closures in effect.

Ore, Willamette NF, USFS. Seven miles northeast of Blue River, OR. Brush and timber. Active fire behavior with uphill runs, backing and isolated torching. Structures threatened. Area, road and trail closures in effect.

Williams Mine, Gifford Pinchot NF, USFS. CIMT (NW Team 13). Four miles northwest of Trout Lake, WA. Brush, timber and heavy slash. Active fire behavior with backing, flanking and creeping. Communities and energy infrastructure threatened. Area, road and trail closures in effect.

Pioneer, Southeast Region, Washington DNR. CIMT (NW Team 3). IMT is also managing the Easy fire. Started on private land 10 miles southeast of Stehekin, WA. Timber and grass. Minimal fire behavior with creeping, backing and smoldering. Numerous structures and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

Easy, Okanogan-Wenatchee NF, USFS. Seventeen miles west of Mazama, WA. Timber and brush. Minimal fire behavior with creeping and smoldering. Structures threatened. Area, road and trail closures in effect.

Sandstone, Mt. Hood NF, USFS. CIMT (NW Team 10). IMT is also managing the Whisky Creek fire. Nine miles southwest of Ripplebrook, OR. Brush and timber. Minimal fire behavior with flanking, backing and creeping. Area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

Whisky Creek, Mt. Hood NF, USFS. Six miles southeast of Cascade Locks, OR. Timber and brush. Minimal fire behavior with flanking, backing and creeping. Area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

Lane 1, East Lane Unit, ODF. IMT 1 (ODF Team 1). Fifteen miles southeast of Springfield, OR. Timber, closed timber litter and light slash. Active fire behavior with flanking, backing and smoldering. Structures, energy and communication infrastructure threatened. Evacuations, area, road and trail closures in effect. Precipitation occurred over fire area yesterday.

Warner Peak, Sheldon-Hart Mountain NWR, FWS. CIMT (SW Team 1). Thirty-two miles northeast of Lakeview, OR. Brush and grass. Active fire behavior with uphill runs, torching and smoldering. Structures and threatened. Area and road closures in effect. Sage-grouse habitat threatened.

Homestead Complex (6 Fires), Umpqua NF, USFS. Transfer of command from CIMT (NW Team 8) to CIMT (NR Team 6) will occur tomorrow. Thirty miles northeast of Glide, OR. Timber, closed timber litter and brush. Moderate fire behavior with flanking, backing and short-range spotting. Structures and communication infrastructure threatened. Area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

Dixon, Umpqua NF, USFS. IMT 1 (ODF Team 2). Eighteen miles east of Canyonville, OR. Timber and slash. Minimal fire behavior with smoldering. Numerous structures, communities and communication infrastructure threatened. Area road and trail closures in effect. Precipitation occurred over the fire area yesterday. Reduction in acreage due to more accurate mapping.

Crazy Creek, Ochoco NF, USFS. CIMT (CA Team 1). Sixteen miles northeast of Paulina, OR. Grass, brush and timber. Minimal fire behavior with backing, creeping and smoldering. Residences threatened. Evacuations, area, road and trail closures in effect.

Retreat, Southeast Region, Washington DNR. CIMT (CA Team 14). Started on private land 14 miles southeast of Naches, WA. Grass, brush and timber. Minimal fire behavior with creeping and smoldering. Numerous structures threatened. Area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

Battle Mountain Complex (2 fires), Pendleton Unit, Oregon DOF. CIMT (SW Team 3). Eight miles north of Ukiah, OR. Grass, hardwood litter and timber. Minimal fire behavior with smoldering. Numerous structures threatened. Area, road and trail closures in effect.

Falls, Malheur NF, USFS. CIMT (NW Team 2). IMT is also managing the Telephone fire. Twenty-six miles northwest of Burns, OR. Timber and grass. Moderate fire behavior with flanking, backing and isolated torching. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Telephone, Malheur NF, USFS. Sixteen miles northeast of Burns, OR. Timber and brush. Minimal fire behavior with backing, creeping and smoldering. Numerous structures and sage-grouse habitat threatened. Evacuations, area, road and trail closures in effect.

Town Gulch, Wallowa-Whitman NF, USFS. Transfer of command from CIMT (SA Team 2) back to the local unit occurred 8/16. Eight miles north of Richland, OR. Timber and grass. Moderate fire behavior with creeping and flanking. Several communities threatened. Evacuations, area, road and trail closures in effect.

Red, Deschutes NF, USFS. Eighteen miles west of Crescent, OR. Timber. Minimal fire behavior with backing, creeping and smoldering. Numerous structures threatened. Area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

Ruby, North Cascades NP, NPS. Thirty-two miles northwest of Stehekin, WA. Timber and brush. Active fire behavior with running, backing and short-range spotting. Structures and threatened. Area and trail closures in effect.

2620 Road, Olympic Region-Department of Natural Resources, DNR. Twenty miles northwest of Bremerton, WA. Timber and slash. Active fire behavior and single tree torching, backing and spotting. Structures threatened. Area, road and trail closures in effect.

Cougar Creek, Southeast Region, Washington DNR. Twenty-three miles southwest of Asotin, WA. Timber and brush. Minimal fire behavior with smoldering. Area, road and trail closures in effect.

Cliff Mountain, Wallowa-Whitman NF, USFS. Twenty-five miles east of Joseph, OR. Grass, brush and timber. No new information.

Predictive Services Discussion:

Breezy southwesterly sustained winds of 12-25 mph with gusts 25-40 mph amid relative of 5-15% will develop along the Sierra Front into much of central Nevada. Lighter winds of 10-15 mph will occur in eastern Oregon to southwest Idaho, but low relative humidity of 5-20% is likely to continue with fair to poor overnight recovery. Isolated mixed wet and dry thunderstorms will develop in far eastern Nevada into east-central Idaho and southwest/central Montana on the fringe of the monsoon moisture plume. To the east, scattered wet thunderstorms will develop across much of Arizona, Utah, western Wyoming, West Slope, and far western New Mexico.

Hot temperatures of 95-110°F will continue across New Mexico, east of the Divide, into the southern Plains and Lower Mississippi Valley. Hot and dry conditions are likely to spread into southeast Colorado, as well. Minimum relative humidity will fall to 10-25% in the Plains and New Mexico, and 30-45% in East Texas to Mississippi. Isolated to scattered mainly wet thunderstorms will develop in southeast Arkansas, Mississippi, and Alabama during the evening along a southward moving cold front, with more widespread showers and thunderstorms developing overnight in eastern Oklahoma and western Arkansas. Scattered to widespread wetting rain is also forecast from the Appalachians to the East Coast ahead of the cold front.
