One MAFFS C-130 airtanker and support personnel from the 152nd Airlift Wing (NV Air National Guard) and one MAFFS C-130 airtanker and support personnel from the 146th Airlift Wing (CA Air National Guard) have been deployed to Port Hueneme, CA to support wildland fire operations nationally.

Sixty Fireline management personnel from Australia and New Zealand are assigned to support large fires in the Northwest Area.

Two hundred forty-five soldiers from the 14th Brigade Engineer Battalion and the 1st Battalion, 17th Infantry Regiment based out of Joint Base Lewis McChord (JBLM) are deployed in support of wildland fire operations on the Boise National Forest. NIMO (Team 2) is assigned to support the military contingent.

Wapiti, Boise NF, USFS. CIMT (RM Team 1). Fourteen miles west of Stanley, ID. Grass, brush and timber. Extreme fire behavior with uphill runs, group torching and short-range spotting. Community of Stanley and numerous structures threatened. Evacuations, area, road and trail closures in effect.

Middle Fork Complex (2 fires), Boise NF, USFS. CIMT (GB Team 3). Nine miles east of Garden Valley, ID. Timber and brush. Active fire behavior with group torching, spotting and backing. Communities of Crouch and Lowman threatened. Evacuations, area, road and trail closures in effect.

Fish Creek, Bridger-Teton NF, USFS. CIMT (NR Team 1). Twenty-two miles southeast of Moran, WY. Timber and brush. Moderate fire behavior with flanking, single tree torching and short-range spotting. Structures and communication infrastructure threatened. Area, road and trail closures in effect.

Snag, Boise NF, USFS. CIMT (RM Team 2). IMT is also managing the Dollar, Boulder, Goat and Wolf Creek fires. Ten miles east of Cascade, ID. Timber and brush. Moderate fire behavior with backing, creeping and group torching. Residences and energy infrastructure threatened. Area, road and trail closures in effect.

Dollar, Boise NF, USFS. Eighteen miles northeast of Cascade, ID. Timber and brush. Moderate fire behavior with wind-driven runs, backing and group torching. Area, road and trail closures in effect.

Boulder, Boise NF, USFS. Nine miles southwest of Cascade, ID. Timber and brush. Minimal fire behavior with backing, creeping and group torching. Structures and communication infrastructure threatened. Area, road and trail closures in effect.

Goat, Boise NF, USFS. Eleven miles southeast of Cascade, ID. Timber and brush. Moderate fire behavior with backing, creeping and group torching. Energy infrastructure threatened. Area, road and trail closures in effect.

Wolf Creek, Payette NF, USFS. Eleven miles northwest of Cascade, ID. Timber and brush. Minimal fire behavior with single tree torching and smoldering. Communication infrastructure threatened.

Boulter, Uinta-Wasatch-Cache NF, USFS. Twenty-five miles west of Santaquin, UT. Chaparral, brush and grass. Minimal fire behavior with creeping and smoldering. Structures, energy infrastructure, transportation infrastructure and sage-grouse habitat threatened.

Limepoint, Payette NF, USFS. Three miles southwest of Cuprum, ID. Timber, brush and grass. Moderate fire behavior with smoldering, single tree torching and creeping. Structures threatened. Area, road and trail closures in effect.

Diamond Complex (2 fires), Umpqua NF, USFS. CIMT (CA Team 4). CIMT (SA Team 3) mobilizing. IMT is also managing the Middle Fork fire. Eighteen miles southwest of Chemult, OR. Brush, timber and medium slash. Minimal fire behavior with creeping and smoldering. Communication and energy infrastructure threatened. Area, road and trail closures in effect.

Middle Fork, Crater Lake NP, NPS. Fourteen miles northeast of Union Creek, OR. Brush, timber and medium slash. Minimal fire behavior with creeping and smoldering. Structures threatened. Area, road and trail closures in effect.

Homestead Complex (4 fires), Umpqua NF, USFS. CIMT (NR Team 6). Thirty miles northeast of Glide, OR. Timber, closed timber litter and brush. Minimal fire behavior with creeping and smoldering. Structures and communication infrastructure threatened. Area, road and trail closures in effect.

Willamette Complex (4 fires), Willamette NF, USFS. CIMT (NW Team 7) and CIMT (EA Team 1). IMTs are also managing the Ore fire. Eight miles southeast of Oakridge, OR. Timber and brush. Minimal fire behavior with creeping and smoldering. Transportation and communication infrastructure threatened. Area, road and trail closures in effect.

Ore, Willamette NF, USFS. Seven miles northeast of Blue River, OR. Closed timber litter and timber. Minimal fire behavior with creeping and smoldering. Structures threatened. Area, road and trail closures in effect.

Whisky Creek, Mt. Hood NF, USFS. CIMT (NW Team 10). CIMT (NW Team 12) mobilizing. IMT is also managing the Sandstone fire. Six miles southeast of Cascade Locks, OR. Timber, brush and closed timber litter. Minimal fire behavior with flanking, backing and creeping. Area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

Sandstone, Mt. Hood NF, USFS. Nine miles southwest of Ripplebrook, OR. Brush, closed timber litter and timber. Minimal fire behavior with flanking, backing and creeping. Energy infrastructure threatened. Area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

Lane 1, East Lane Unit, ODF. CIMT (AK Team 1). Fifteen miles southeast of Springfield, OR. Timber, closed timber litter and light slash. Moderate fire behavior with backing and creeping. Structures threatened. Evacuations, area, road and trail closures in effect.

Pioneer, Southeast Region, Washington DNR. Transfer of command from CIMT (NW Team 3) back to local unit will occur tomorrow. Started on private land 10 miles southeast of Stehekin, WA. Timber and grass. Minimal fire behavior with creeping and smoldering. Numerous structures threatened. Area, road and trail closures in effect.

Williams Mine, Gifford Pinchot NF, USFS. Four miles northwest of Trout Lake, WA. Brush, timber and light slash. Minimal fire behavior with smoldering, creeping and backing. Energy infrastructure threatened. Area, road and trail closures in effect.

Crazy Creek, Ochoco NF, USFS. Sixteen miles northeast of Paulina, OR. Grass, brush and timber. Minimal fire behavior with smoldering and creeping. Evacuations, area, road and trail closures in effect.

Ruby, North Cascades NP, NPS. Thirty-two miles northwest of Stehekin, WA. Timber and brush. Minimal fire behavior with smoldering and creeping. Structures threatened. Area and trail closures in effect.

Red, Deschutes NF, USFS. Eighteen miles west of Crescent, OR. Timber and closed timber litter. Minimal fire behavior with backing, creeping and smoldering. Numerous structures threatened. Area, road and trail closures in effect.

Upper Ruby, Colville NF, USFS. Sixteen miles northwest of Cusick, WA. Medium slash and closed timber litter. Active fire behavior with creeping and smoldering. Structures threatened. Reduction in acreage due to more accurate mapping.

Battle Mountain Complex (2 fires), Pendleton Unit, Oregon DOF. Eight miles north of Ukiah, OR. Grass, hardwood litter and timber. Minimal fire behavior with smoldering. Numerous structures threatened. Area, road and trail closures in effect.

Predictive Services Discussion:

Hot and dry conditions will continue in much of Tennessee, northern Alabama, and northern Mississippi, with minimum relative humidity of 15-30%. Moisture will slowly move north into central Mississippi and central Alabama, with isolated to scattered afternoon thunderstorms that could result in lightning ignitions. Farther west, moisture will continue to increase in the southern Plains with scattered afternoon showers and thunderstorms. Scattered showers and thunderstorms will also develop from the Ohio Valley into the Mid-Atlantic and Northeast, while isolated to scattered monsoon thunderstorms will develop in eastern Arizona and much of New Mexico.

Breezy, dry, post-frontal westerly winds are likely in much of Montana, Wyoming, and the Snake River Plain, with locally elevated fire weather conditions. The strongest winds are likely in north-central Montana due to downslope enhancement, but relative humidity is expected to be significantly higher, above 30%. Much of the Inland Northwest, Great Basin, California, and Arizona will remain dry, with afternoon relative humidity below 20%. Above normal temperatures will continue in California, Nevada, Utah, and Arizona, with near to below normal temperatures in the northern Intermountain West. Locally breezy north winds are expected in portions of northern California, as well.
