Predictive Services Discussion:

Dry and breezy conditions will develop ahead of a cold front across the southern Great Basin, West Slope, and Southwest into West Texas. Westerly sustained winds of 10-25 mph with gusts 20-35 mph will develop amid minimum relative humidity of 5-20%. Elevated fire weather conditions are most likely in eastern Arizona into southern New Mexico and far west Texas where winds will be strongest and humidity lowest. An atmospheric river will continue to move through the Northwest, northern Rockies, and northern Great Basin with widespread wetting rain, while California is cool with higher relative humidity. Scattered showers and thunderstorms are forecast to develop across much of the northern and eastern Plains into the Mississippi Valley. The East Coast will continue to remain dry with only isolated light showers forecast for the Southeast coast. Florida will remain hot with minimum relative humidity falling to near 20% for central Florida, while isolated thunderstorms and new lightning ignitions are possible over south Florida. Slightly above normal temperatures and isolated thunderstorms will continue for much of Interior Alaska, with scattered showers for south-central Alaska, while trade winds and windward showers diminish for Hawai'i today.
