Predictive Services Discussion:

Alaska will have well above average temperatures, with isolated to scattered thunderstorms with frequent lightning are also forecast. The Pacific Northwest, east of the Cascades, will see warmer temperatures today and low relative humidity, with Oregon in the teens and Washington in the mid-20s. California will see hot and dry conditions, with the relative humidity in the Central Valley dropping to around 20%. The Mojave and Sonoran Deserts will remain hot with low relative humidity, while the greater Four Corners will see drier conditions. The northern Rockies are forecast to see cooler and drier weather today, with showers and isolated thunderstorms for the northern High Plains. The Great Basin will be warmer and drier, with relative humidity around 10%. The southern and south-central Plains into Texas will see hot temperatures with relative humidity in the teens into the mid 20%, while severe weather is possible in the Plains and northern Mississippi Valley. The Gulf Coast, Lower Mississippi Valley, and Atlantic Coast states are forecast to see scattered showers and thunderstorms, while high temperatures forecast to be in the low 90s.
