Hurricane Helene Support – NC, North Carolina Forest Service. CIMT (NC State). Primary mission is to coordinate emergency road clearing efforts, perform damage assessments and deliver commodities throughout western North Carolina.

* **Bowman Branch**, Kentucky DOF. Started on private land 8 miles west of Jackson, KY. Timber, light slash and grass. Active fire behavior with running, uphill runs and wind-driven runs. Structures threatened.

Forked Mouth 9, Kentucky DOF. Previously reported incident. Started on private land 5 miles west of Hazard, KY. Hardwood litter and grass. Active fire behavior with wind-driven runs, uphill runs and running. Structures threatened.

Hudson, Texas A&M Forest Service. Started on private land 5 miles east of Bastrop, TX. Timber, brush and grass. Minimal fire behavior with smoldering. Residences threatened. Precipitation occurred over the fire area yesterday.

Rush, Wichita Mountains National Wildlife Refuge, FWS. Fifteen miles northwest of Lawton, OK. Timber, grass and brush. Minimal fire behavior. Numerous structures threatened. Area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

Red – Goblin, Daniel Boone NF, USFS. Twelve miles southeast of Manchester, KY. Hardwood litter and light slash. No new information.

Predictive Services Discussion:

Breezy north to northeasterly offshore winds this morning across northern and central California into tonight. The winds will spread south into southern California by noon today with a strong Santa Ana wind event as northeasterly winds gust as high as 80 mph and relative humidity falls as low as 6%. An upper low in the Southwest will bring widespread showers to the southern Rockies into the High Plains, with snow falling above 4,000 to 6,000 feet. A weakening cold front will move through the Northeast and into the Appalachians, with scattered light showers in the Northeast and more widespread showers in the Appalachians. Moisture will increase across the Southeast with scattered to widespread showers and thunderstorms. Cool, but dry conditions are forecast across the Northwest eastward into the northern Plains.
