NIMO Team 1 has been mobilized to assist Disaster Recovery Staff with organizing a safe, efficient and orderly transition from response to recovery in all hurricane impacted areas across the Southern Region.

Hurricane Helene Support – NC, North Carolina Forest Service. CIMT (NC State). Primary mission is to coordinate emergency road clearing efforts, perform damage assessments and deliver commodities throughout western North Carolina.

* **Caney Fork Road**, Kentucky DOF. Started on private land five miles south of Pilgrim, KY. Timber and hardwood litter. Active fire behavior with uphill runs and creeping. Structures threatened.

* **Dorton Hill Road**, Kentucky DOF. Started on private land two miles northeast of Dorton, KY. Hardwood litter. Active fire behavior with running, flanking and backing. Structures threatened.

* **Turkey Creek**, Kentucky DOF. Started on private land one mile northeast of Inez, KY. Timber. Active fire behavior with uphill runs and running. Structures threatened.

* **Old Roughy**, National Forests in North Carolina. Five miles northwest of Robbinsville, NC. Hardwood litter. Moderate fire behavior. Residences threatened.

* **Huntingdon Pike**, Pennsylvania DOF. Seven miles southeast of Altoona, PA. Hardwood litter, timber and brush. Active fire behavior with running, backing and flanking.

* **Whitehouse**, New York State Department of Environmental Conservation. One mile north of Sundown, NY. Hardwood litter. Moderate fire behavior with running, flanking and backing. Residences threatened.

* **Mount Gilead**, Massachusetts Bureau of Forest Fire Control. Started on private land four miles east of Wakefield, MA. Timber and brush. Extreme fire behavior with short crown runs, wind-driven runs, and running. Residences threatened.

Middleton Pond, Massachusetts Bureau of Forest Fire Control. Started on private land one mile west of Middleton, MA. Hardwood litter, grass and brush. Moderate fire behavior with creeping and smoldering. Last report unless significant activity occurs.

Highland, New River Gorge National Park and Preserve, NPS. Two miles east of Prince, WV. Hardwood litter and light slash. No new information. Last report unless new information is received.

Lost Run, West Virginia DOF. Three miles northwest of Dunlow, WV. Hardwood litter and timber. No new information. Last report unless new information is received.

Predictive Services Discussion:

A cold front will move through the northern Intermountain West today and into California, the great Basin, and central Rockies tonight. Breezy and dry southerly winds will develop in the central and southern Great Basin today ahead of the front, with precipitation spreading from the Northwest into northern California, the central and northern Great Basin, and northern Rockies. Snow levels will begin above 6,000 feet ahead of the front, and fall to near 4,000 feet behind the front. A weakening cold front will move off the East Coast today and tonight with scattered light precipitation in the Southeast, and scattered thunderstorms along the northern Gulf Coast. Another cold front will move through the Great Lakes and Northeast through tonight, with scattered showers, mainly downwind of the Great Lakes.
