**Valley**, Southwest Supervisory Area Office, Idaho Department of Lands. One mile east of Boise, ID. Grass and brush. Moderate fire behavior with creeping, isolated torching and smoldering. Numerous residences threatened. Trail closures in effect.

**Yellow Lake**, Uinta-Wasatch-Cache NF, USFS. CIMT (CA Team 2) mobilizing. Ten miles southeast of Francis, UT. Timber and medium slash. Active fire behavior with running, spotting and wind-driven runs. Several communities, numerous structures and sage-grouse habitat threatened. Evacuations, area, road and trail closures in effect.

**Pack Trail**, Bridger-Teton NF, USFS. CIMT (CA Team 10). Includes acreage from the previously reported Fish Creek fire. Twenty-five miles southeast of Moran, WY. Timber. Active fire behavior with group torching, short-range spotting and flanking. Several communities and structures threatened. Evacuations, area, road and trail closures in effect.

**Red Rock**, Salmon-Challis NF, USFS. CIMT (SW Team 3). Fifteen miles west of Salmon, ID. Timber and light slash. Active fire behavior with backing, group torching and crowning. Numerous structures threatened. Evacuations, area, road and trail closures in effect. Reduction in acreage due to more accurate mapping.

**Goat**, Boise NF, USFS. CIMT (GB Team 6). IMT is also managing the Snag fire and the Middle Fork Complex. Eleven miles southeast of Cascade, ID. Timber and brush. Moderate fire behavior with flanking, backing and group torching. Numerous structures and energy infrastructure threatened. Area, road and trail closures in effect.

**Snag**, Boise NF, USFS. Ten miles east of Cascade, ID. Timber and brush. Minimal fire behavior with creeping, smoldering and backing. Energy infrastructure threatened. Area, road and trail closures in effect.

**Middle Fork Complex (2 fires)**, Boise NF, USFS. Nine miles east of Garden Valley, ID. Timber and brush. Minimal fire behavior with creeping, smoldering and backing. Area, road and trail closures in effect.

**Rosie**, Southwest Supervisory Area Office, Idaho Department of Lands. Twenty-five miles southeast of Jordan Valley, OR. Medium slash and grass. Moderate fire behavior with flanking, creeping and isolated torching. Structures threatened.

**Lava**, Boise NF, USFS. Transfer of command from CIMT (RM Team 2) back to the local unit will occur tomorrow. Twelve miles southwest of Cascade, ID. Timber and brush. Minimal fire behavior with creeping and smoldering. Numerous residences threatened. Area, road and trail closures in effect.

**Wapiti**, Boise NF, USFS. CIMT (GB Team 3). IMT is also managing the Frog fire. Fourteen miles west of Stanley, ID. Grass, brush and timber. Moderate fire behavior with flanking, backing and creeping. Structures threatened. Area, road and trail closures in effect.

**Frog**, Sawtooth NF, USFS. Nineteen miles southeast of Stanley, ID. Grass, brush and timber litter. Moderate fire behavior with flanking and creeping. Area, road and trail closures in effect.

**Tiger Creek**, Umatilla NF, USFS. CIMT (CA Team 15). Fifteen miles southeast of Walla Walla, WA. Timber, brush and grass. Moderate fire behavior with flanking, backing and creeping. Area, road and trail closures in effect.

**Bingham**, Willamette NF, USFS. CIMT (CA Team 1). Two miles east of Marion Forks, OR. Closed timber litter, timber and brush. Minimal fire behavior. Structures threatened. Area, road and trail closures in effect.

**Rail Ridge**, Prineville District, BLM. CIMT (NW Team 8). Fifty-one miles northwest of Burns, OR. Grass, brush and timber. Active fire behavior with flanking, isolated torching and short-range spotting. Structures and communication infrastructure threatened. Area, road and trail closures in effect.

**Homestead Complex (4 fires)**, Umpqua NF, USFS. CIMT (NW Team 12). IMT is also managing the Diamond Complex. Thirty miles northeast of Glide, OR. Timber, closed timber litter and brush. Minimal fire behavior with smoldering and creeping. Structures and communication infrastructure threatened. Area, road and trail closures in effect.

**Diamond Complex (2 fires)**, Umpqua NF, USFS. Eighteen miles southwest of Chemult, OR. Timber. Minimal fire behavior with smoldering and creeping. Area, road and trail closures in effect.

**Willamette Complex (4 fires)**, Willamette NF, USFS. Eight miles southeast of Oakridge, OR. Timber, brush and grass. Moderate fire behavior with flanking, backing and single tree torching. Area, road and trail closures in effect.

## **Predictive Services Discussion:**

Well above normal, record-setting temperatures will continue in the Southwest and southern California, with well above normal temperatures throughout the northern Intermountain West and much of the Plains. Minimum relative humidity will be 5-20% for much of the West, with minima of 15-25% on the Plains. Dry conditions will continue across the Midwest and much of the Mississippi Valley as well, where relative humidity will fall as low as 20%, although winds will be light. Winds in the West and Plains are likely to be light also, except for portions of Wyoming and Montana east of the Divide where westerly winds gusting to 35 mph are possible. Isolated, mainly dry, thunderstorms will develop over northeast California, the eastern Sierra, and central Nevada in the afternoon. Drier conditions are expected across much of the Appalachians and East Coast, except for lingering showers in eastern New England. Heavy rain is possible across the Florida Peninsula along a stalled cold front.
