**Hurricane Helene Support - NC**, Federal Emergency Management Agency (FEMA). CIMT (RM Team 1). Primary mission is to coordinate emergency road clearing efforts and provide community support to the counties surrounding Newton, NC.

**Hurricane Helene Support - NC**, National Forests in North Carolina, USFS. CIMT (SA Team 2). Primary mission is to coordinate emergency road clearing efforts and protect critical infrastructure on the Pisgah and Nantahala National Forests near Asheville, NC.

**Hurricane Helene Support – TN & VA,** National Forests in Tennessee and Virginia, USFS. CIMT (SA Team 3). Primary mission is to assess damage, coordinate emergency road clearing efforts and assist with critical infrastructure restoration on the Cherokee National Forest and the George Washington and Jefferson National Forest.

**Hurricane Milton Support - FL**, Florida Forest Service. CIMT (FL State Team 4). Primary mission is to stage resources to deploy after landfall and preform urban search and rescue as conditions permit in central Florida and along Florida's west coast.

**Yellow Lake**, Uinta-Wasatch-Cache NF, USFS. CIMT (CA Team 2). Ten miles southeast of Francis, UT. Timber and medium slash. Active fire behavior with group torching, running and short-range spotting. Several

communities, numerous structures and sage-grouse habitat threatened. Evacuations, area, road and trail closures in effect.

**Pack Trail**, Bridger-Teton NF, USFS. CIMT (CA Team 10). Twenty-five miles southeast of Moran, WY. Timber. Moderate fire behavior with group torching, flanking and backing. Several communities and numerous structures threatened. Evacuations, area, road and trail closures in effect.

**Red Rock**, Salmon-Challis NF, USFS. CIMT (SW Team 3). Fifteen miles west of Salmon, ID. Timber and light slash. Active fire behavior with backing, group torching and crowning. Numerous structures, energy infrastructure and sage-grouse habitat threatened. Evacuations, area, road and trail closures in effect.

**Castle Ridge**, Elko District, BLM. Three miles north of Midas. NV. Grass and brush. Active fire behavior with wind-driven runs and uphill runs. The community of Midas, structures and sage-grouse habitat threatened.

**Logan**, Payette NF, USFS. Previously reported incident. One mile west of Edwardsburg, ID. Closed timber litter and timber. Active fire behavior with uphill runs, backing and torching. Numerous structures threatened. Evacuations and area closures in effect. Last narrative report unless significant activity occurs.

**Valley**, Southwest Supervisory Area Office, Idaho Department of Lands. One mile east of Boise, ID. Grass and brush. Moderate fire behavior with creeping, isolated torching and smoldering. Numerous residences threatened. Trail closures in effect.

**Goat**, Boise NF, USFS. CIMT (GB Team 6). IMT is also managing the Snag fire and the Middle Fork Complex. Eleven miles southeast of Cascade, ID. Timber and brush. Moderate fire behavior with flanking, backing and single tree torching. Numerous structures and energy infrastructure threatened. Area, road and trail closures in effect.

**Snag**, Boise NF, USFS. Ten miles east of Cascade, ID. Timber and brush. Minimal fire behavior with creeping, smoldering and backing. Energy infrastructure threatened. Area, road and trail closures in effect.

**Middle Fork Complex (2 fires)**, Boise NF, USFS. Nine miles east of Garden Valley, ID. Timber and brush. Minimal fire behavior with creeping, smoldering and backing. Area, road and trail closures in effect.

**Rosie**, Southwest Supervisory Area Office, Idaho Department of Lands. Twenty-five miles southeast of Jordan Valley, OR. Medium slash and grass. Moderate fire behavior with isolated torching, flanking and backing. Structures and sage-grouse habitat threatened.

**Lava**, Boise NF, USFS. Twelve miles southwest of Cascade, ID. Timber and brush. Minimal fire behavior with smoldering and creeping. Numerous residences threatened. Area, road and trail closures in effect.

**Wapiti**, Boise NF, USFS. Transfer of command from CIMT (GB Team 3) back to the local unit will occur today. IMT is also managing the Frog fire. Fourteen miles west of Stanley, ID. Grass, brush and timber. Moderate fire behavior with torching, uphill runs, and backing. Residences threatened. Area, road and trail closures in effect.

**Frog**, Sawtooth NF, USFS. Nineteen miles southeast of Stanley, ID. Grass, brush and timber litter. Minimal fire behavior with flanking, backing and creeping. Area, road and trail closures in effect.

**Tiger Creek**, Umatilla NF, USFS. CIMT (CA Team 15). Fifteen miles southeast of Walla Walla, WA. Timber, brush and grass. Moderate fire behavior with creeping, spotting and smoldering. Area, road and trail closures in effect. Reduction in acreage due to more accurate mapping.

**Rail Ridge**, Prineville District, BLM. CIMT (NW Team 8). Fifty-one miles northwest of Burns, OR. Grass, brush and timber. Active fire behavior with uphill runs, group torching and spotting. Structures and communication infrastructure threatened. Area, road and trail closures in effect.

**Bingham**, Willamette NF, USFS. CIMT (CA Team 1). Two miles east of Marion Forks, OR. Closed timber litter, timber and brush. Minimal fire behavior with creeping and smoldering. Structures threatened. Evacuations, area, road and trail closures in effect.

#### **Predictive Services Discussion:**

Well above normal, record-setting temperatures will continue in the Southwest, albeit slightly cooler than previous days, while much of central/northern California is several degrees cooler due to onshore flow. Minimum relative humidity will be 5-20% for much of the West, but it will increase to above 20% across portions of coastal California and the Inland Northwest, while minima of 15-30% occur on the Plains into the Mississippi Valley, Appalachians, and Great Lakes. A few showers will continue in western Washington, but breezy southwesterly winds of 12-20 mph gusting to 25-35 mph will develop ahead of a dry cold front across the Inland Northwest into northeast California, the Great Basin, Montana, and Wyoming creating areas of elevated conditions. Very isolated mixed wet and dry thunderstorms will develop across the Colorado Rockies into northern New Mexico.

Well above normal temperatures will spread onto much of the Plains, with locally breezy southerly winds of 15-20 mph on the southern High Plains. Breezy and dry northerly winds will occur in the Lower Mississippi and Tennessee Valleys, but winds will remain lighter in the Great Lakes. Hurricane Milton is expected to make landfall on the west coast of Florida overnight bringing strong winds, heavy rain with extensive inland flooding, and catastrophic storm surge near the coast.
