Hurricane Helene Support – NC, Federal Emergency Management Agency (FEMA). CIMT (RM Team 1). Primary mission is to coordinate emergency road clearing efforts and provide community support to the counties surrounding Newton, NC.

Hurricane Helene Support – NC, National Forests in North Carolina, USFS. CIMT (SA Team 2). Primary mission is to coordinate emergency road clearing efforts and protect critical infrastructure on the Pisgah and Nantahala National Forests near Asheville, NC.

Hurricane Helene Support – NC, North Carolina Forest Service. CIMT (NC State). Primary mission is to coordinate emergency road clearing efforts, preform damage assessments and deliver commodities throughout western North Carolina.

Hurricane Helene Support – TN & VA, National Forests in Tennessee and Virginia, USFS. CIMT (SA Team 3). Primary mission is to assess damage, coordinate emergency road clearing efforts and assist with critical infrastructure restoration on the Cherokee National Forest and the George Washington and Jefferson National Forest.

Hurricane Milton Support – FL, Florida Forest Service. CIMT (FL State Team 4). Primary mission is to stage resources to deploy after landfall and preform urban search and rescue as conditions permit in central Florida and along Florida’s west coast.

Yellow Lake, Uinta-Wasatch-Cache NF, USFS. CIMT (CA Team 2). Ten miles southeast of Francis, UT. Timber, medium slash and grass. Active fire behavior with short crown runs, group torching, and long-range spotting. Several communities, numerous structures and sage-grouse habitat threatened. Evacuations, area, road and trail closures in effect.

Pack Trail, Bridger-Teton NF, USFS. CIMT (CA Team 10). Twenty-five miles southeast of Moran, WY. Timber, medium slash and brush. Active fire behavior with group torching, short-range spotting and flanking. Several communities and numerous structures threatened. Evacuations, area, road and trail closures in effect.

Red Rock, Salmon-Challis NF, USFS. CIMT (SW Team 3). Fifteen miles west of Salmon, ID. Chaparral, hardwood litter and timber. Active fire behavior with uphill runs, wind driven runs and torching. Numerous structures and sage-grouse habitat threatened. Evacuations, area, road and trail closures in effect.

Garden, Salmon-Challis NF, USFS. Previously reported incident. Twenty-five miles northwest of Salmon, ID. Timber. Active fire behavior with single tree torching, group torching and uphill runs. Numerous structures threatened. Evacuations in effect. Last narrative report unless significant activity occurs.

Logan, Payette NF, USFS. CIMT (GB Team 3). One mile west of Edwardsburg, ID. Timber, brush and closed timber litter. Active fire behavior with uphill runs, backing and group torching. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Castle Ridge, Elko District, BLM. Three miles north of Midas. NV. Grass and brush. Minimal fire behavior with smoldering and creeping. Sage-grouse habitat threatened.

Valley, Southwest Supervisory Area Office, Idaho Department of Lands. One mile east of Boise, ID. Timber and grass. Moderate fire behavior with creeping, isolated torching and smoldering. Numerous residences threatened. Area and trail closures in effect.

Goat, Boise NF, USFS. CIMT (GB Team 6). IMT is also managing the Snag fire and the Middle Fork Complex. Eleven miles southeast of Cascade, ID. Timber, brush and grass. Moderate fire behavior with flanking, backing and single tree torching. Numerous structures threatened. Area, road and trail closures in effect.

Snag, Boise NF, USFS. Ten miles east of Cascade, ID. Timber and brush. Minimal fire behavior with creeping, smoldering and backing. Energy infrastructure threatened. Area, road and trail closures in effect.

Middle Fork Complex (2 fires), Boise NF, USFS. Nine miles east of Garden Valley, ID. Timber and brush. Minimal fire behavior with creeping, smoldering and backing. Area, road and trail closures in effect.

Rosie, Southwest Supervisory Area Office, Idaho Department of Lands. Twenty-five miles southeast of Jordan Valley, OR. Medium slash and grass. Minimal fire behavior with isolated torching, flanking and backing. Structures and sage-grouse habitat threatened.

Lava, Boise NF, USFS. Twelve miles southwest of Cascade, ID. Timber and closed timber litter. Minimal fire behavior with smoldering, creeping and backing. Numerous residences threatened. Area, road and trail closures in effect.

Farrow, Payette NF, USFS. Previously reported incident. Forty-eight miles southeast of Elk City, ID. Timber and grass. Moderate fire behavior with backing, flanking and isolated torching. Last narrative report unless significant activity occurs.

Birch, Salmon-Challis NF, USFS. Previously reported incident. Includes the acreage from the previously reported Mowitch fire. Forty-four miles northwest of Challis, ID. Timber. Active fire behavior with short crown runs, short-range spotting and group torching. Structures threatened. Last narrative report unless significant activity occurs.

Commissary, Caribou-Targhee NF, USFS. Previously reported incident. Fourteen miles south of Swan Valley, ID. Timber. Moderate fire behavior with group torching, uphill runs and single tree torching. Last narrative report unless significant activity occurs.

Rail Ridge, Prineville District, BLM. CIMT (NW Team 8). Fifty-one miles northwest of Burns, OR. Timber and brush. Moderate fire behavior with flanking, backing and isolated torching. Structures and communication infrastructure threatened. Area, road and trail closures in effect.

Tiger Creek, Umatilla NF, USFS. CIMT (CA Team 15). Fifteen miles southeast of Walla Walla, WA. Timber, brush and grass. Minimal fire behavior with creeping, smoldering and backing. Area, road and trail closures in effect. Reduction in acreage due to more accurate mapping.

Bingham, Willamette NF, USFS. CIMT (CA Team 1). IMT is also managing the Willamette Complex and Young Grasshopper fire. Two miles east of Marion Forks, OR. Grass, timber and brush. Minimal fire behavior with smoldering. Structures threatened. Evacuations, area, road and trail closures in effect.

Willamette Complex (4 fires), Willamette NF, USFS. Eight miles southeast of Oakridge, OR. Closed timber litter, timber and medium slash. Minimal fire behavior with backing, creeping and smoldering. Area, road and trail closures in effect.

Young Grasshopper, Willamette NF, USFS. Previously reported incident. Fifteen miles northeast of Oakridge, OR. Timber, brush and light slash. Minimal fire behavior with backing, creeping and smoldering. Area, road and trail closures in effect.

Bachelor Complex, Deschutes NF, USFS. Twenty miles southwest of Bend, OR. Timber and closed timber litter. Active fire behavior with wind-driven runs, short-range spotting and single tree torching. Area, road and trail closures in effect.

Pine, Prineville District, BLM. Twenty-four miles southeast of Bend, OR. Brush, grass and timber. Minimal fire behavior with smoldering and creeping. Sage-grouse habitat, energy and communication infrastructure threatened. Area and road closures in effect.

Predictive Services Discussion:

Temperatures will remain above normal across the Intermountain West, with the greatest anomalies over the Southwest and Four Corners. Minimum relative humidity will remain low at 8-20% for the Great Basin, Southwest, central Rockies, and High Plains, but higher at 15-30% for California, the Inland Northwest, and northern Rockies. Breezy southwesterly winds will develop across much of the Great Basin into Wyoming and the West Slope creating elevated. Breezy south to southeasterly winds will develop across northeast Wyoming into eastern Montana, as well.

Breezy and dry northerly winds will develop in the Upper Mississippi Valley behind a dry cold front, with dry southwesterly winds ahead of the front in the Lower Great Lakes. Breezy southerly winds will also develop in central Texas and Oklahoma. Much of the US will remain dry today, with little to no precipitation forecast although a few light showers may move onto the northern California coast Friday night. A few showers are also possible in northern New England and along the east coast of Florida.
