Predictive Services Discussion:

A weak upper low will slowly drift south and east over the Great Basin in the middle of upper-level ridging over the West. Isolated to scattered high-based showers and thunderstorms are likely ahead of the upper low in the Greater Four Corners region. While wetting rain is possible with some of these storms, most areas will receive less than 0.10". Farther south and southeast across Arizona, New Mexico, and southwest Texas, well above normal temperatures, minimum relative humidity of 8-20%, and breezy southerly winds are expected. Dry and breezy conditions will continue on the Plains, with southerly winds returning to portions of the southern and central Plains, while parts of central and east Texas will remain hot, dry, and breezy. Breezy westerly downslope winds are expected to develop in portions of northwest and north-central Montana amid minimum relative humidity of 15-25% as well. A strong cold front will eventually move off the East and Gulf Coasts, with drier, cooler, and occasionally breezy post-frontal conditions across much of the eastern US. Showers remain likely along and downwind of the Great Lakes and across much of New England. In the Pacific Northwest, onshore flow with scattered showers will begin over western Washington and northwest Oregon as an upper-level trough approaches the West Coast. Dry/breezy Cascade Gap winds are likely as onshore flow strengthens.

National Predictive Services Outlook
