Hurricane Helene Support – NC, North Carolina Forest Service. CIMT (NC State). Primary mission is to coordinate emergency road clearing efforts, perform damage assessments and deliver commodities throughout western North Carolina.

Hurricane Helene Support – TN & VA, National Forests in Tennessee and Virginia, USFS. Transfer of command from CIMT (SA Team 3) back to the local unit will occur today. Primary mission is to assess damage, coordinate emergency road clearing efforts and assist with critical infrastructure restoration on the Cherokee NF and the George Washington and Jefferson NF.

Yellow Lake, Uinta-Wasatch-Cache NF, USFS. CIMT (CA Team 2). Ten miles southeast of Francis, UT. Timber, medium slash and grass. Active fire behavior with short crown runs, group torching, and short-range spotting. Several communities, communication infrastructure and sage-grouse habitat threatened. Evacuations, area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

Pack Trail, Bridger-Teton NF, USFS. CIMT (CA Team 10). Twenty-five miles southeast of Moran, WY. Timber, medium slash and brush. Active fire behavior with group torching, spotting and flanking. Several communities and numerous structures threatened. Evacuations, area, road and trail closures in effect.

Red Rock, Salmon-Challis NF, USFS. CIMT (SW Team 3). Fifteen miles west of Salmon, ID. Grass and timber. Active fire behavior with uphill runs, group torching and spotting. Sage-grouse habitat threatened. Evacuations, area, road and trail closures in effect.

Logan, Payette NF, USFS. CIMT (GB Team 3). One mile west of Edwardsburg, ID. Timber, brush and closed timber litter. Active fire behavior with uphill runs, backing and isolated torching. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

* **Verdure Creek**, Manti-La Sal National Forest, USFS. Six miles southwest of Monticello, UT. Timber and dormant brush. Moderate fire behavior with running, single tree torching and short-range spotting. Structures threatened.

Valley, Southwest Supervisory Area Office, Idaho Department of Lands. One mile east of Boise, ID. Timber and grass. Moderate fire behavior with creeping, isolated torching and smoldering. Numerous residences threatened. Area and trail closures in effect.

Goat, Boise NF, USFS. Transfer of command from CIMT (GB Team 6) back to the local unit will occur tomorrow. IMT is also managing the Snag fire and the Middle Fork Complex. Eleven miles southeast of Cascade, ID. Timber, brush and grass. Moderate fire behavior with flanking, backing and creeping. Numerous structures threatened. Area, road and trail closures in effect.

Snag, Boise NF, USFS. Ten miles east of Cascade, ID. Timber and brush. Minimal fire behavior with creeping, smoldering and backing. Area, road and trail closures in effect.

Middle Fork Complex (2 fires), Boise NF, USFS. Nine miles east of Garden Valley, ID. Timber and brush. Minimal fire behavior with creeping, smoldering and backing. Area, road and trail closures in effect.

Lava, Boise NF, USFS. Twelve miles southwest of Cascade, ID. Timber and closed timber litter. Minimal fire behavior with creeping, backing and smoldering. Numerous residences threatened. Area, road and trail closures in effect.

Castle Ridge, Elko District, BLM. Three miles north of Midas, NV. Grass and brush. Minimal fire behavior with smoldering. Sage-grouse habitat threatened.

Rosie, Southwest Supervisory Area Office, Idaho Department of Lands. Twenty-five miles southeast of Jordan Valley, OR. Medium slash and grass. Minimal fire behavior with isolated torching, flanking and backing. Structures and sage-grouse habitat threatened.

Cherry Creek Road, West Desert District, BLM. Five miles southwest of Silver City, UT. Brush, grass and chaparral. Active fire behavior with isolated torching, smoldering and creeping. Structures threatened.

Predictive Services Discussion:

A weak upper low will continue to spin over northern Arizona, with continued chances of isolated high-based showers and thunderstorms to the Greater Four Corners region. Stronger southwest flow aloft will continue to spread farther inland over the northwest US ahead of an upper-level trough off the Pacific Northwest Coast, including across the northern Great Basin later in the forecast period, mainly overnight. Showers will spread east across portions of the Inland Northwest into north Idaho and south into northwest California overnight, as well. Southerly flow will increase across portions of the northern and central Plains, which will create areas of locally elevated conditions.

A deep upper-level trough will swing southeast through the eastern US reinforcing a cold front and pushing it south and west through the southern Plains and farther into the Gulf of Mexico. Dry and breezy post-frontal conditions will develop across much of the southern/central Plains into portions of the Southeast, with elevated conditions likely in some areas. North-northeast sustained winds of 12-20 mph gusting 25-35 mph amid minimum relative humidity of 15-30% and temperatures mostly in the 50s and 60s are expected in the post-frontal airmass. Hot, dry, and breezy conditions will occur ahead of the cold front in portions of central and Texas. Isolated to scattered showers remain likely from the Great Lakes into portions of the central Appalachians and Northeast.
