Predictive Services Discussion:

Weakening low-pressure will move into the central and northern Plains with scattered showers and thunderstorms. Well above normal temperatures will continue across the northern Plains into the Great Lakes and Mid-Mississippi Valley, with the lowest relative humidity of 15-25% in the Mid-Mississippi Valley along with southerly winds of 10-15 mph. Low relative humidity of 15-25% amid above normal temperatures will also continue from eastern Oklahoma and Texas into the Southeast and Appalachians but winds will be light. A Pacific cold front will move through the Northwest and into the northern Rockies, with moderate rainfall and snow in the mountains above 7,000 feet. However, little precipitation is likely to fall in eastern Oregon. Mild and dry weather will continue in California, with drier air spreading into the southern Rockies, as well.
