Predictive Services Discussion:

A cold front will quickly move through the northern and central Plains into the Great Lakes. However, the front will be mainly dry, with a few showers possible in northern Minnesota into the Upper Great Lakes. Locally breezy and dry downslope westerly winds are likely near and east of the Divide in Montana and Wyoming, with breezy northwesterly winds behind the front in the Dakotas. Ahead of the front, very dry air will continue from eastern Oklahoma and Texas into the Ohio Valley, Appalachians, and Southeast as minimum relative humidity falls to 15-25%. Breezy southerly winds of 10-20 mph are expected in portions of eastern Oklahoma into Arkansas for locally elevated conditions. In the West, near normal temperatures and light winds are expected for much of the northern two-thirds of the West. However, temperatures will begin to warm to above normal across the Mojave and Sonoran Deserts with low afternoon relative humidity of 5-15%.
