Rush, Wichita Mountains National Wildlife Refuge, FWS. CIMT (SA Team 1) mobilizing. Fifteen miles northwest of Lawton, OK. Grass and brush. Extreme fire behavior with wind-driven runs, flanking and spotting. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

* **Low Water**, Oklahoma DOF. Eight miles west of Jay, OK. Hardwood litter. Active fire behavior. Structures threatened.

Predictive Services Discussion:

The majority of the country will be dry and unseasonably warm today, but cooler temperatures are moving in behind a cold front that passed through the Great Lakes and New England overnight. Record high temperatures will be most common over central and southern Arizona into southwest New Mexico, in addition to the Gulf Coast, Georgia and South Carolina. Rain showers will continue for western parts of Oregon and Washington into far northwestern California, while a few mixed rain and snow showers will be possible in northern New England. A few showers and thunderstorms may develop along a stalling frontal boundary from northeast Texas to the Carolinas, but wetting rain will be hard to come by. More humid conditions either side of this front will help mitigate initial attack potential compared to previous days. Minimum RH in the upper single digits and teens will be common in lower elevations of the West, while values in the central and northern Plains and ahead of the front in the coastal Southeast will range from the high teens to low 30s. Gusty downslope winds will return to portions of Montana and Wyoming, but most areas in the West will be relatively calm. Moderate significant fire potential will continue for parts of the Northern Rockies, Rocky Mountains and Southern Area, in addition to southern Arizona, while hot and dry conditions followed by sea breeze winds will maintain high-risk significant fire potential in southern Alabama and Mississippi. Meanwhile, downslope winds will gust as high as 20-35 mph over the Northeast and Mid-Atlantic, which will maintain areas of elevated fire danger along the coastal plain from Maine to the Delmarva Peninsula.
