NIMO (Team 2) is assigned to support the military contingent.

**Dollar**, Boise NF, USFS. Eighteen miles northeast of Cascade, ID. Timber and brush. Moderate fire behavior with uphill runs, backing and group torching. Area, road and trail closures in effect.

**Goat**, Boise NF, USFS. Eleven miles southeast of Cascade, ID. Timber and brush. Active fire behavior with uphill runs, backing and group torching. Energy infrastructure threatened. Area, road and trail closures in effect.

Moderate fire behavior with creeping, smoldering and isolated torching. Communication and energy infrastructure threatened. Area, road and trail closures in effect.

**Middle Fork**, Crater Lake NP, NPS. Fourteen miles northeast of Union Creek, OR. Timber. Moderate fire behavior with smoldering, creeping and isolated torching. Structures threatened. Area, road and trail closures in effect.

**Ore**, Willamette NF, USFS. Seven miles northeast of Blue River, OR. Closed timber litter and timber. Active fire behavior with uphill runs, flanking and backing. Structures threatened. Area, road and trail closures in effect.

**Homestead Complex (4 fires)**, Umpqua NF, USFS. CIMT (NW Team 8). Thirty miles northeast of Glide, OR. Timber, closed timber litter and brush. Minimal fire behavior with creeping and smoldering. Structures and communication infrastructure threatened. Area, road and trail closures in effect.

Whisky Creek, Mt. Hood NF, USFS. CIMT (NW Team 12). IMT is also managing the Sandstone fire. Six miles southeast of Cascade Locks, OR. Timber, brush and closed timber litter. Minimal fire behavior with smoldering, creeping and backing. Energy and transportation infrastructure threatened. Area, road and trail closures in effect.

**Sandstone**, Mt. Hood NF, USFS. Nine miles southwest of Ripplebrook, OR. Brush, closed timber litter and timber. Minimal fire behavior with smoldering and creeping. Energy infrastructure threatened. Area, road and trail closures in effect.

#### **Predictive Services Discussion:**

Another day of hot temperatures and very low relative humidity of 4-20% is forecast across California into the northern two-thirds of the Intermountain West. However, some cooling is forecast west of the Cascades, with higher humidity. Locally breezy westerly winds of 15-20 mph gusting to 30 mph are likely along the Sierra Front and through the Cascade Gaps. Dry and breezy south to southeasterly winds will develop amid above normal temperatures on the northern and central High Plains, with the strongest winds likely in eastern Wyoming into southeast Montana.

Isolated, mainly dry, thunderstorms are forecast to develop across much of central and eastern Nevada into southern Utah and the West Slope, with isolated to scattered mainly wet thunderstorms in Arizona. Isolated dry thunderstorms are likely to develop in south-central Oregon as well. Overnight, isolated dry thunderstorms will develop across northern Nevada into central and southeast Oregon and southwest Idaho. Isolated dry thunderstorms may also develop overnight near and west of the Oregon Cascades, but confidence is low. A weakening cold front will move into the South, with isolated to scattered wet thunderstorms and cooler temperatures. Heavy rain is also likely to continue in far southeast Texas and southern Louisiana due to low pressure in the northwestern Gulf of Mexico
