Sixty fireline management personnel from Australia and New Zealand are assigned to support large fires in the Northwest Area.

Two hundred forty-five soldiers from the 14th Brigade Engineer Battalion and the 1st Battalion, 17th Infantry Regiment based out of Joint Base Lewis McChord (JBLM) are deployed in support of wildland fire operations on the Boise National Forest. NIMO (Team 2) is assigned to support the military contingent.

Numerous structures and several communities threatened. Evacuations, area, road and trail closures in effect.

Nine miles southwest of Cascade, ID. Timber and brush. Moderate fire behavior with uphill runs, backing and group torching. Numerous structures and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

**Snag**, Boise NF, USFS. Ten miles east of Cascade, ID. Timber and brush. Moderate fire behavior with backing, group torching and single tree torching. Residences and energy infrastructure threatened. Area, road and trail closures in effect.

**Goat**, Boise NF, USFS. Eleven miles southeast of Cascade, ID. Timber and brush. Moderate fire behavior with backing, group torching and single tree torching. Communication and energy infrastructure threatened. Area, road and trail closures in effect.

**Dollar**, Boise NF, USFS. Eighteen miles northeast of Cascade, ID. Timber and brush. Moderate fire behavior with backing, group torching and single tree torching. Area, road and trail closures in effect.

**Chimney**, Eastern Supervisory Area Office, Idaho Department of Lands. CIMT (SW Team 4) mobilizing. Nine miles northwest of Fairfield, ID. Brush and timber. Moderate fire behavior with backing, creeping and smoldering. Structures and sage-grouse habitat threatened. Area, road and trail closures in effect. Reduction in acreage due to more accurate mapping.

**Two Cabin**, Fossil Unit, ODF. Four miles northeast of Monument, OR. Grass and brush. Extreme fire behavior with running, spotting and torching.

#### **Predictive Services Discussion:**

The upper-level ridge will strengthen over the West, with temperatures as much as 20 degrees above normal and numerous daily records possible from Arizona and California to the Pacific Northwest. Temperatures up to 110°F are expected in the California Central Valley, and near or exceeding 100°F in the Willamette Valley of Oregon. Well above normal temperatures will spread east to the Continental Divide, as well. Very low minimum RH of 4-20% will spread across the West, west of the Divide, with poor overnight recovery of 10-30% for mid-slopes and ridges focused on the Great Basin, Northwest, California, and Arizona. Winds overall will be light, but locally gust easterly winds of 10-15 mph will occur in the Columbia Gorge and the northern Wasatch Front. Significant fire potential will remain low to moderate due to a lack of ignition sources, but ongoing fires are likely to increase in activity due to other fire environment factors. Even so, smoke shading may cause locally cooler temperatures and higher RH resulting in less activity for some fires than would otherwise be expected based on background conditions.

A backdoor cold front will move into New Mexico and Colorado with increasing moisture east of the Divide and much cooler temperatures along with scattered showers and isolated thunderstorms. A cold front will move through the Midwest with scattered showers and thunderstorms, while scattered to widespread showers and thunderstorms develop from East Texas into western Georgia, but there will be a sharp northern boundary to the rainfall with the Tennessee Valley likely to remain dry. Ahead of the cold front, RH as low as 25% is expected to continue in the Upper Ohio Valley.
