Sixty fireline management personnel from Australia and New Zealand are assigned to support large fires in the Northwest Area.

Two hundred forty-five soldiers from the 14th Brigade Engineer Battalion and the 1st Battalion, 17th Infantry Regiment based out of Joint Base Lewis McChord (JBLM) are deployed in support of wildland fire operations on the Boise National Forest. NIMO (Team 2) is assigned to support the military contingent.

Active fire behavior with torching, spotting and flanking. Numerous structures and several communities threatened. Evacuations, area, road and trail closures in effect.

**Boulder**, Boise NF, USFS. CIMT (RM Team 3). IMT is also managing the Snag, Goat and Dollar fires. Nine miles southwest of Cascade, ID. Timber and brush. Moderate fire behavior with uphill runs, backing and group torching. Numerous structures and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

**Snag**, Boise NF, USFS. Ten miles east of Cascade, ID. Timber and brush. Moderate fire behavior with uphill runs, backing and group torching. Residences and energy infrastructure threatened. Area, road and trail closures in effect.

**Goat**, Boise NF, USFS. Eleven miles southeast of Cascade, ID. Timber and brush. Moderate fire behavior with uphill runs, backing and group torching. Energy infrastructure threatened. Area, road and trail closures in effect.

**Dollar**, Boise NF, USFS. Eighteen miles northeast of Cascade, ID. Timber and brush. Moderate fire behavior with backing, group torching and single tree torching. Area, road and trail closures in effect.

**Chimney**, Eastern Supervisory Area Office, Idaho Department of Lands. CIMT (SW Team 4) mobilizing. Nine miles northwest of Fairfield, ID. Brush and timber. Active fire behavior with running, creeping and torching. Structures and sage-grouse habitat threatened. Area, road and trail closures in effect.

**Fish Creek**, Bridger-Teton NF, USFS. CIMT (NR Team 1). CIMT (NR Team 2) mobilizing. Twenty-two miles southeast of Moran, WY. Timber and brush. Active fire behavior with short crown runs, group torching and long-range spotting. Structures and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

**Middle Fork Complex (2 fires)**, Boise NF, USFS. Transfer of command from CIMT (GB Team 3) to CIMT (GB Team 5) will occur today. Nine miles east of Garden Valley, ID. Timber and brush. Moderate fire behavior with backing, flanking and group torching. Several communities threatened. Area, road and trail closures in effect.

**Lava**, Boise NF, USFS. Twelve miles southwest of Cascade, ID. Timber and brush. Active fire behavior with short-range spotting, uphill runs and flanking. Structures threatened. Area, road and trail closures in effect.

**Sheep**, Boise NF, USFS. Ten miles east of Idaho City, ID. Timber. Moderate fire behavior with running, flanking and backing.

**Berry**, Boise District, BLM. Eight miles northeast of Glenns Ferry, ID. Grass and brush. Minimal fire behavior with smoldering. Residences and Sage-Grouse habitat threatened.

**Mineral**, Boise District, BLM. Started on private land 21 miles northwest of Weiser, ID. Grass and brush. Moderate fire behavior with creeping and smoldering. Structures threatened.

**Limepoint**, Payette NF, USFS. Three miles southwest of Cuprum, ID. Timber, brush and grass. Moderate fire behavior with creeping, single tree torching and smoldering. Numerous structures threatened. Area, road and trail closures in effect.

\* **Plex**, Boise District, BLM. Nine miles southeast of Boise, ID. Grass and Brush. Moderate fire behavior with running and flanking. Numerous residences and energy infrastructure threatened. Road closures in effect.

**Lake Mountain**, Elko County Fire Protection District. Thirty-two miles northwest of Elko, NV. Brush and grass. Minimal fire behavior with smoldering and creeping. Reduction in acreage due to more accurate mapping.

**Rail Ridge**, Prineville, District, BLM. CIMT (CA Team 10). Fifty-one miles northwest of Burns, OR. Grass, brush and timber. Active fire behavior with running and torching. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

**Wiley Flat**, Ochoco NF, USFS. CIMT (CA Team 1). Thirty-one miles southeast of Prineville, OR. Timber, brush and grass. Extreme fire behavior with short crown runs and short-range spotting. Structures threatened. Evacuations, area and road closures in effect.

**Shoe Fly**, Prineville Unit, ODF. IMT 1 (ODF Team 1). IMT is also managing Two Cabin fire. Forty-five miles northeast of Prineville, OR. Brush, grass and timber. Extreme fire behavior with uphill runs, spotting and torching. Numerous structures and communication infrastructure threatened. Evacuations and road closures in effect.

**Two Cabin**, Fossil Unit, ODF. Four miles northeast of Monument, OR. Grass and brush. Active fire behavior with flanking, backing and isolated torching.

**Copperfield**, Klamath Unit, ODF. IMT 1 (ODF Team 3). Five miles southeast of Chiloquin, OR. Timber, brush and grass. Moderate fire behavior with backing, creeping and smoldering. Numerous structures and energy infrastructure threatened. Evacuations and road closures in effect.

**Willamette Complex (4 fires)**, Willamette NF, USFS. CIMT (CA Team 13) and CIMT (NW Team 2). IMTs are also managing the Ore fire. Eight miles southeast of Oakridge, OR. Timber, brush and grass. Minimal fire behavior with flanking, smoldering and creeping. Structures, energy and transportation infrastructure threatened. Area, road and trail closures in effect.

#### **Predictive Services Discussion:**

The upper-level ridge will continue over the West, with the high's center moving into the Great Basin. Temperatures will be as much as 20 degrees above normal, with numerous daily records continuing, especially near and west of the Cascades and Sierra. Low minimum RH of 4-20% will continue as well, with poor overnight recovery of 10-30% for mid-slopes and ridges across the Intermountain West. Winds will be light, but a weak upper-level low moving into northern California is likely to produce isolated dry thunderstorms in the northern Sierra, northwest California, and southwest/south-central Oregon. While storms are expected to remain isolated and not nearly as prolific lightning producers as early this week, ignitions efficiency is expected to be high, with many new ignitions and a few emerging large fires possible. Isolated thunderstorms may continue overnight, mainly in southwest and central Oregon.

Limited moisture will move west into eastern Arizona with isolated mixed wet/dry thunderstorms possible along the Mogollon Rim and into much of New Mexico and southwest Colorado. While fuels conditions are not as dry, fuels have been drying quickly with the heat. A cold front will move through the eastern Great Lakes and Ohio Valley, but rainfall is expected to be scattered in the Ohio Valley. Farther south, widespread showers and thunderstorms will spread into the Southeast, but a sharp northern boundary of rainfall will continue, with mainly dry conditions in the Tennessee Valley and southern Appalachians.
