**Firestone**, Deschutes NF, USFS. Twenty-one miles north of Fort Rock, OR. Grass, brush and timber. Extreme fire behavior with crowning, torching and long-range spotting. Structures threatened. Evacuations, area, road and trail closures in effect.

**Flat Top**, Deschutes NF, USFS. Ten miles north of Fort Rock, OR. Grass, brush and timber. Extreme fire behavior with crowning, torching and long-range spotting. Structures threatened.

**Rail Ridge**, Prineville, District, BLM. CIMT (CA Team 10). Fifty-one miles northwest of Burns, OR. Grass, brush and timber. Active fire behavior with wind-driven runs, torching and short-range spotting. Numerous structures, communication infrastructure and sage-grouse habitat threatened. Evacuations, area, road and trail closures in effect.

**Fossil Complex (3 fires)**, Fossil Unit, ODF. IMT 1 (ODF Team 2). Two miles northwest of Spray, OR. Timber. Active fire behavior with spotting, torching and uphill runs. Structures and communication infrastructure threatened. Evacuations and road closures in effect.

**Willamette Complex (4 fires)**, Willamette NF, USFS. CIMT (CA Team 13) and CIMT (NW Team 2). IMTs are also managing the Ore fire. Eight miles southeast of Oakridge, OR. Timber, brush and grass. Moderate fire behavior with backing, single tree torching and spotting. Communication and transportation infrastructure threatened. Area, road and trail closures in effect.

**Ore**, Willamette NF, USFS. Seven miles northeast of Blue River, OR. Closed timber litter and timber. Moderate fire behavior with isolated torching, flanking and backing. Structures threatened. Area, road and trail closures in effect.

**Devils Knob**, Umpqua NF, USFS. CIMT (NW Team 13). IMT is also managing the Milepost 98 fire. Five miles southeast of Tiller, OR. Timber. Active fire behavior with spotting, running and backing. Structures threatened. Evacuations in effect.

**Milepost 98**, South Unit, ODF. One mile north of Canyonville, OR. Light slash and timber. Active fire behavior with flanking, backing and creeping. Structures threatened. Road closures in effect. Reduction in acreage due to more accurate mapping.

**Wiley Flat**, Ochoco NF, USFS. CIMT (CA Team 1). Thirty-one miles southeast of Prineville, OR. Timber, brush and grass. Active fire behavior with group torching, flanking and backing. Structures and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

**Shoe Fly**, Prineville Unit, ODF. IMT 1 (ODF Team 1). Forty-five miles northeast of Prineville, OR. Brush, grass and timber. Moderate fire behavior with flanking, backing and creeping. Numerous structures and communication infrastructure threatened. Evacuations and road closures in effect.

**Homestead Complex (4 fires)**, Umpqua NF, USFS. CIMT (NW Team 8). IMT is also managing the Lane 1 fire. Thirty miles northeast of Glide, OR. Timber, closed timber litter and brush. Minimal fire behavior with

backing, flanking and creeping. Structures and communication infrastructure threatened. Area, road and trail closures in effect.

**Lane 1**, East Lane Unit, ODF. Fifteen miles southeast of Springfield, OR. Timber, closed timber litter and light slash. Minimal fire behavior with backing and creeping. Structures threatened. Area, road and trail closures in effect.

**Diamond Complex (2 fires)**, Umpqua NF, USFS. CIMT (SA Team 3). CIMT (CA Team 14) mobilizing. IMT is also managing the Middle Fork fire. Eighteen miles southwest of Chemult, OR. Timber. Minimal fire behavior with creeping and smoldering. Communication and energy infrastructure threatened. Area, road and trail closures in effect.

**Middle Fork**, Crater Lake NP, NPS. Fourteen miles northeast of Union Creek, OR. Timber. Minimal fire behavior with creeping and smoldering. Area, road and trail closures in effect.

**Whisky Creek**, Mt. Hood NF, USFS. Transfer of command from CIMT (NW Team 12) back to the local unit occurred yesterday. Six miles southeast of Cascade Locks, OR. Timber, brush and closed timber litter. Moderate fire behavior with uphill runs, backing and flanking. Structures and energy infrastructure threatened. Area, road and trail closures in effect.

**Sandstone**, Mt. Hood NF, USFS. Nine miles southwest of Ripplebrook, OR. Brush, closed timber litter and timber. Minimal fire behavior with smoldering and creeping. Area, road and trail closures in effect.

**Copperfield**, Klamath Unit, ODF. IMT 1 (ODF Team 3). Five miles southeast of Chiloquin, OR. Timber, brush and grass. Minimal fire behavior with smoldering. Numerous structures and energy infrastructure threatened. Evacuations and road closures in effect.

**Buck Creek**, Fremont-Winema NF, USFS. CIMT (NW Team 10). IMT is also managing Bowman Well Fire. Thirty miles southwest of Silver Lake, OR. Timber and medium slash. Extreme fire behavior with running, torching and crowning.

**Bowman Well**, Lakeview District. BLM. Twenty miles northeast of Silver Lake, OR. Brush and grass. Moderate fire behavior with single tree torching, creeping and smoldering. Area closures in effect. Reduction in acreage do to more accurate mapping.

**Huckleberry Ridge**, Pacific Cascade Region, DNR. Twenty miles south of Pe Ell, WA. Heavy slash and timber. Moderate fire behavior with backing and smoldering. Area and road closures in effect.

**Pioneer**, Southeast Region, Washington DNR. Started on private land 10 miles southeast of Stehekin, WA. Timber and grass. Minimal fire behavior with smoldering. Numerous structures threatened. Area, road and trail closures in effect. Reduction in acreage due to more accurate mapping.

**Battle Mountain Complex (2 fires)**, Pendleton Unit, ODF. Eight miles north of Ukiah, OR. Grass, hardwood litter and timber. Minimal fire behavior with smoldering. Last report unless significant activity occurs.

**Ruby**, North Cascades NP, NPS. Thirty-two miles northwest of Stehekin, WA. Timber and brush. Minimal fire behavior with creeping and backing. Area and trail closures in effect.

**Williams Mine**, Gifford Pinchot NF, USFS. Four miles northwest of Trout Lake, WA. Brush, timber and light slash. Minimal fire behavior with creeping and smoldering. Energy infrastructure threatened. Area, road and trail closures in effect.

**Easy**, Okanogan-Wenatchee NF, USFS. Seventeen miles west of Mazama, WA. Timber, closed timber litter and brush. Minimal fire behavior. Structures threatened. Area, road and trail closures in effect.

**Crazy Creek**, Ochoco NF, USFS. Sixteen miles northeast of Paulina, OR. Grass, brush and timber. Minimal fire behavior with smoldering and creeping. Last report unless significant activity occurs.

**Red**, Deschutes NF, USFS. Eighteen miles west of Crescent, OR. Timber and closed timber litter. Moderate fire behavior with single tree torching, backing and spotting. Numerous structures threatened. Area, road and trail closures in effect.

**Sage Hen**, Burns District, BLM. Ten miles west of Burns, OR. Grass, brush and timber. No new information. Last report unless new information is received.

#### **Predictive Services Discussion:**

A deep upper-level trough will move into the Pacific Northwest. The cold front associated with this system will move into northern California, the Great Basin, and into the Northern Rockies through the day. Ahead of this front, very strong winds will develop over the Intermountain West, and especially across the Great Basin. Sustained west to northwest winds of 20 to 30 mph are expected to develop by early afternoon. Gusts will be 30 to 45 mph, with localized gusts exceeding 50 mph or more exposed ridges and mountain passes from the Sierra through the Great Basin and along the Sierra Front. Relative humidity will drop to 5 to 25%, resulting in widespread critical fire weather conditions. Cooler temperatures and higher humidity are expected behind the cold front, along with wetting precipitation from the Cascades through much of Oregon into the northern Rockies.

In the Southeast, winds will be increasing from Louisiana into Tennessee as Hurricane Francine approaches, with landfall expected in the afternoon. Wind gusts of 20 to 25 mph and relative humidity of 20 to 30% are expected in the Tennessee Valley, while the Louisiana coast sees hurricane force winds and heavy rain. Elsewhere in the east, temperatures will continue to increase as high pressure settles over the Great Lakes, with much of the eastern US likely to remain dry outside the effects of Francine.
