Bridge, Angeles NF, USFS. CIMT (CA Team 5). Six miles northeast of Glendora, CA. Chaparral, brush and grass. Active fire behavior with flanking, backing and isolated torching. Numerous structures, communication and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

Active fire behavior with uphill runs, short-range spotting and running. Numerous structures, energy and communication infrastructure threatened. Bachelor Complex, Deschutes NF, USFS. CIMT (NW Team 3). IMT is also managing the Firestone and Flat Top fires. Twenty miles southwest of Bend, OR. Timber and closed timber litter. Moderate fire behavior with flanking, backing and creeping. Numerous structures threatened. Evacuations, area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

Firestone, Deschutes NF, USFS. Twenty-one miles north of Fort Rock, OR. Grass, brush and timber. Moderate fire behavior with flanking, backing and creeping. Residences, energy and communication infrastructure threatened. Evacuations, area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

Flat Top, Deschutes NF, USFS. Ten miles north of Fort Rock, OR. Grass, brush and timber. Moderate fire behavior with flanking, backing and creeping. Numerous residences, sage-grouse habitat and energy infrastructure threatened. Precipitation occurred over the fire area yesterday.

Rail Ridge, Prineville, District, BLM. CIMT (CA Team 10). Fifty-one miles northwest of Burns, OR. Grass, brush and timber. Moderate fire behavior with smoldering, creeping and backing. Numerous structures, communication infrastructure and sage-grouse habitat threatened. Evacuations, area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

Devils Knob, Umpqua NF, USFS. CIMT (NW Team 13). IMT is also managing the Milepost 98 fire. Five miles southeast of Tiller, OR. Timber. Moderate fire behavior with smoldering, backing and creeping. Structures threatened. Precipitation occurred over the fire area yesterday.

Milepost 98, South Unit, ODF. One mile north of Canyonville, OR. Light slash and timber. Minimal fire behavior with smoldering and creeping. Structures threatened. Precipitation occurred over the fire area yesterday.

Timber, brush and grass. Minimal fire behavior with creeping, smoldering and single tree torching. Area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

Ore, Willamette NF, USFS. Seven miles northeast of Blue River, OR. Closed timber litter and timber. Minimal fire behavior with creeping and smoldering. Structures threatened. Area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

Red, Deschutes NF, USFS. Eighteen miles west of Crescent, OR. Timber and closed timber litter. Minimal fire behavior with creeping, torching and smoldering. Numerous structures threatened. Area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

Homestead Complex (4 fires), Umpqua NF, USFS. Transfer of command from CIMT (NW Team 8) to CIMT (NW Team 7) will occur today. IMT is also managing the Lane 1 fire. Thirty miles northeast of Glide, OR. Timber, closed timber litter and brush. Minimal fire behavior with smoldering, creeping and backing. Structures and communication infrastructure threatened. Area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

Lane 1, East Lane Unit, ODF. Fifteen miles southeast of Springfield, OR. Timber, closed timber litter and light slash. No new information. Last report unless significant activity occurs.

Diamond Complex (2 fires), Umpqua NF, USFS. Transfer of command from CIMT (SA Team 3) to CIMT (CA Team 14) will occur today. IMT is also managing the Middle Fork fire. Eighteen miles southwest of Chemult, OR. Timber. Minimal fire behavior with creeping and smoldering. Communication infrastructure threatened. Area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

Middle Fork, Crater Lake NP, NPS. Fourteen miles northeast of Union Creek, OR. Timber. Minimal fire behavior with creeping and smoldering. Area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

Shoe Fly, Prineville Unit, ODF. IMT 1 (ODF Team 1). Forty-five miles northeast of Prineville, OR. Brush, grass and timber. Minimal fire behavior with creeping, smoldering and backing. Precipitation occurred over the fire area yesterday.

Huckleberry Ridge, Pacific Cascade Region, DNR. Twenty miles south of Pe Ell, WA. Heavy slash and timber. Minimal fire behavior with smoldering. Area and road closures in effect.

Swauk Creek, Southeast Region, Washington DNR. Two miles south of Liberty, WA. Brush and timber. Moderate fire behavior with backing. Structures threatened. Area, road and trail closures in effect.

Pioneer, Southeast Region, Washington DNR. Started on private land 10 miles southeast of Stehekin, WA. Timber and grass. Minimal fire behavior with smoldering. Numerous structures threatened. Area, road and trail closures in effect.

Predictive Services Discussion:

Drier conditions are expected across much of the West tomorrow with minimum relative humidity of 15-30%, but temperatures will remain near to below normal. Breezy and dry westerly winds gusting up to 30 mph amid relative humidity of 7-20% are expected to continue across the Mojave Desert into the Southwest and southern High Plains. Above normal temperatures will continue on the Plains into the Upper Mississippi Valley, Great Lakes, central Appalachians, and Northeast. Aside from locally breezy southerly winds on the Plains, winds are expected to remain light overall, with relative humidity above 25% in the East. The remnants of Francine will bring widespread wetting rain to the Tennessee Valley into portions of the Lower Ohio/Mid-Mississippi Valleys, while showers and thunderstorms spread into much of Georgia and Florida, as well.
