**Wiley Flat**, Ochoco NF, USFS. CIMT (AK Team 3). IMT is also managing the Rail Ridge fire. Thirty-one miles southeast of Prineville, OR. Timber, brush and grass. Minimal fire behavior with smoldering. Structures threatened. Area, road and trail closures in effect.

**Rail Ridge**, Prineville, District, BLM. Fifty-one miles northwest of Burns, OR. Grass, brush and timber. Moderate fire behavior with flanking, backing and isolated torching. Structures and communication infrastructure threatened. Area, road and trail closures in effect.

Minimal fire behavior with smoldering and creeping. Structures and communication infrastructure threatened. Area, road and trail closures in effect.

#### **Predictive Services Discussion:**

A slowly weakening low pressure system over the Tennessee Valley will continue to bring widespread rain, locally heavy, to the Ohio/Tennessee/Shenandoah Valleys, central and southern Appalachians and portions of the Mid-Atlantic through Saturday night. The heaviest rainfall should focus across Middle and West Tennessee, much of Kentucky, far southern portions of Illinois and Indiana as well as western Virgina. These areas can broadly expect 1-3 inches with isolated higher amounts. Elsewhere, scattered showers and thunderstorms will develop over central/south Florida to the coastal areas of the Carolinas while a few showers develop from the eastern Great Lakes to the Mid-Atlantic.

Strong upper-level ridging will extend from the Southwest into the central and northern Plains and western Great Lakes while a strengthening wave of lower pressure approaches the Pacific Northwest late in the day into Saturday night.

Above to well above normal temperatures across much of the West will trend even warmer/hotter with record heat likely for many locations especially across portions of the Great Basin, southeast California and the Southwest amid RH of 5-20%. Late season heat also returns to the Upper Midwest and northern Plains following Friday's brief cool down. Winds should be relatively light across the West, overall, except for locally gusty northeast winds over northeast California, and typical breeziness east of the Divide in Montana and Wyoming.
