# **Predictive Services Discussion:**

A strong storm will move into the Great Lakes today, with an associated strong cold front moving off the East Coast. Widespread moderate rain is expected from the Great Lakes and Appalachians to the East Coast, with severe thunderstorms likely for the East Coast, although only scattered light precipitation is forecast for much of Florida. Strong northwest winds will occur behind the storm across much of the central Plains and Midwest, with heavy snow and localized blizzard conditions from western Iowa northeast into the Upper Peninsula of Michigan. Breezy and dry westerly winds are expected from East Texas to the Southeast behind the cold front, but recent precipitation will mitigate. An upper-level low will move into California, with widespread precipitation across the southern two-thirds of the West, west of the Divide. Snow levels will range from 3,000 to 4,000 feet in the northern Great Basin and northern California to 6,000 to 7,000 feet in the Greater Four Corners. Well above normal temperatures will continue across the Alaskan Interior today, while mixed precipitation occurs in southwest Alaska and strong easterly winds blow across the western coast. Strong trade winds will blow across Hawai'i today along with a few windward showers.
