**Covington Drive**, South Carolina Forestry Commission. CIMT (FL State Team 1) mobilizing. Two miles west of Myrtle Beach, SC. Southern rough. Active fire behavior. Numerous residences threatened. Area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

**Hicks Cemetery**, National Forests in North Carolina, USFS. Fourteen miles northwest of Clyde, NC. Hardwood litter and timber. Active fire behavior with creeping and smoldering. Residences and communication infrastructure threatened. Precipitation occurred over the fire area yesterday.

**Twin Oryx**, Texas A&M Forest Service. Started on private land 25 miles southeast of Cotulla, TX. Grass. Moderate fire behavior with creeping.

## **Predictive Services Discussion:**

Strong southwesterly sustained winds of 20-40 mph gusting to 60 mph amid relative humidity of 10-20% will create critical conditions today across southern and eastern New Mexico into the southern High Plains. Breezy westerly winds are also expected across the Southeast as relative humidity falls into the teens but conditions will be mitigated by recent rainfall. Strong northwesterly winds are also forecast in the Great Lakes to the Mid-Atlantic, but homogeneous will be higher. An upper-level low will move into the western Great Basin today with widespread rain across the southern half of the West except New Mexico, with snow falling above 4,000 to 5,000 feet. Areas of heavy snow will also spread into Wyoming and western Nebraska tonight. Mild temperatures will continue across much of Alaska, with rain and snow in the southwest and snow across portions of the Interior.
