* **Crabapple**, Texas A&M Forest Service. Started on private land six miles northeast of Fredricksburg, TX. Timber. Extreme fire behavior with wind-driven runs, long-range spotting and crowning. Residences threatened. Evacuations in effect.

840 Road, Oklahoma DOF. Five miles southeast of Angora, OK. Timber and grass. Active fire behavior with single tree torching, creeping and smoldering.

Windmill, Texas A&M Forest Service. Started on private land 22 miles south of Perryton, TX. Grass and brush. Active fire behavior. Structures threatened.

Rest Area, Texas A&M Forest Service. Started on private land five miles west of Alanreed, TX. Grass. Active fire behavior with flanking and creeping.

Euchee Valley, Oklahoma DOF. Four miles southwest of Cushing, OK. Grass and timber. Minimal fire behavior with creeping and smoldering.

* **Long Mountain**, Oklahoma DOF. Thirty-seven miles northeast of McAlester, OK. Timber and grass. Extreme fire behavior with wind-driven runs, running and flanking.

* **Oak Leaf**, Okmulgee Agency, BIA. Four miles south of Weleetka, OK. Timber. Extreme fire behavior with wind-driven runs, spotting and short-range spotting. Structures threatened.

* **Cherry Tree**, Oklahoma DOF. Four miles southwest of Westville, OK. Timber. Active fire behavior. Residences threatened.

* **Pinelands**, Florida Forest Service. Ten miles west of St. Lucie West, FL. Grass and timber. Active fire behavior with flanking and creeping.

* **Tully Hollow**, Oklahoma DOF. Six miles northwest of Proctor, OK. Timber. Moderate fire behavior.

* **Dixon Road**, Kentucky DOF. Two miles west of Cumberland, KY. Active fire behavior with running, flanking and backing. Numerous structures threatened. Precipitation occurred over the fire area yesterday.

* **344**, Florida Forest Service. Seven miles east of Florida City, FL. Grass. Active fire behavior with flanking.

* **Lake Pasture**, Texas A&M Forest Service. Started on private land 27 miles south of Victoria, TX. Hardwood litter. Moderate fire behavior.

Onyx, Oklahoma DOF. Three miles northeast of Maguire, OK. Grass and timber. Moderate fire behavior with creeping and smoldering.

Big Draw, Oklahoma DOF. Four miles southwest of Battiest, OK. Timber. Moderate fire behavior with wind-driven runs and torching.

Covington Drive, South Carolina Forestry Commission. CIMT (FL State Team 1). Two miles west of Myrtle Beach, SC. Southern rough and timber. Minimal fire behavior with smoldering and creeping.

Walker Mission Ridge Drive, Georgia Forestry Commission. Started on private land one mile west of White Oak, GA. Hardwood litter and timber. Minimal fire behavior with smoldering. Structures threatened.

Hamby Ridge, Oklahoma DOF. Four miles southeast of Colcord, OK. Timber. Minimal fire behavior.

Eagle Bluff, Oklahoma DOF. Five miles northeast of Grandview, OK. Timber. Moderate fire behavior. Residences threatened.

Post Oak, Oklahoma DOF. Three miles northeast of Maguire, OK. Timber and grass. Moderate fire behavior with smoldering and creeping. Reduction in acreage due to more accurate mapping. Last report unless significant activity occurs.

Hickory Hill Road, Oklahoma DOF. Three miles northeast of Arcadia, OK. Grass and timber. No new information.

1980 Road, Oklahoma DOF. Three miles northeast of Elk City, OK. Timber and grass. No new information.

Davis, Oklahoma DOF. Three miles southeast of Stigler, OK. Timber and grass. No new information.

Mullins Cove Road, Tennessee DOF. Six miles northwest of Hill City, TN. Hardwood litter. No new information.

Predictive Services Discussion:

Low minimum relative humidity of 8-20% will continue today across much of the central and southern Plains, spreading into the Mississippi Valley. However, winds will be lighter today, and generally less than 15 mph. A strong cold front will move off the East Coast today bringing locally heavy rain to the coast and a few severe thunderstorms east of the Appalachians. A Pacific storm will continue moving through the northern half of the West with valley rain and heavy mountain snow. Strong westerly winds will develop across Wyoming into the Nebraska Panhandle and western South Dakota, with elevated to critical conditions likely in the High Plains where RH is lowest. Near normal temperatures continue in Alaska, while light southeasterly trade winds and periods of showers are expected for Hawai'i.
