Crabapple, Texas A&M Forest Service. Started on private land six miles northeast of Fredricksburg, TX. Timber. Moderate fire behavior. Residences threatened. Road closures in effect.

* **Station #2**, Oklahoma DOF. Fourteen miles east of Norman, OK. Grass and timber. Extreme fire behavior with driven-runs, single tree torching and short-range spotting.

840 Road, Oklahoma DOF. Five miles southeast of Angora, OK. Timber and grass. Active fire behavior with single tree torching and creeping.

* **33 Road**, Oklahoma DOF. Seven miles northeast of Arcadia, OK. Grass and timber. Active fire behavior with creeping, single tree torching and smoldering.

* **Bear**, Cherokee NF, USFS. Seven miles southwest of Newport, TN. Hardwood litter and brush. Active fire behavior with uphill runs, wind-driven runs and flanking. Structures threatened.

Windmill, Texas A&M Forest Service. Started on private land 22 miles south of Perryton, TX. Grass and brush. Moderate fire behavior with uphill runs. Structures threatened.

* **Persimmon**, McFaddin NWR, FWS. Nine miles west of Sabine Pass, TX. Grass. Extreme fire behavior.

* **Hellroaring Creek**, Oklahoma DOF. Seven miles southeast of Pawnee, OK. Extreme fire behavior with wind-driven runs, torching and short-range spotting. Residences threatened. Evacuations in effect.

Euchee Valley, Oklahoma DOF. Four miles southwest of Cushing, OK. Grass and timber. Moderate fire behavior with single tree torching, creeping and smoldering. Reduction in acreage due to more accurate mapping.

* **Eight Mile Mountain**, Oklahoma DOF. Ten miles northwest of Talihina, OK. Hardwood litter and timber. Active fire behavior with wind-driven runs and torching. Residences threatened.

Hickory Hill Road, Oklahoma DOF. Three miles northeast of Arcadia, OK. Grass and timber. Moderate fire behavior with single tree torching and creeping.

* **Ferrier**, Oklahoma DOF. Seven miles northwest of Westville, OK. Timber. Moderate fire behavior.

* **Venison Hollow**, Seven miles northwest of Westville, OK. Timber. Moderate fire behavior. Structures threatened.

Long Mountain, Oklahoma DOF. Thirty-seven miles northeast of McAlester, OK. Timber and grass. Minimal fire behavior. Reduction in acreage due to more accurate mapping.

Dixon Road, Kentucky DOF. Two miles west of Cumberland, KY. Timber and hardwood litter. Minimal fire behavior with smoldering. Numerous structures threatened. Precipitation occurred over the fire area yesterday.

Covington Drive, South Carolina Forestry Commission. CIMT (FL State Team 1). Two miles west of Myrtle Beach, SC. Southern rough and timber. Minimal fire behavior with smoldering. Precipitation occurred over the fire area yesterday.

Big Draw, Oklahoma DOF. Four miles southwest of Battiest, OK. Timber. Minimal fire behavior with creeping and smoldering.

Hamby Ridge, Oklahoma DOF. Four miles southeast of Colcord, OK. Timber. Moderate fire behavior.

* **Ketcher Hollow**, Oklahoma DOF. Four miles southeast of Wilburton, OK. Hardwood litter and timber. Minimal fire behavior.

* **Brushy Church**, Oklahoma DOF. Thirteen miles southeast of McAlester, OK. Timber and grass. Minimal fire behavior.

1980 Road, Oklahoma DOF. Three miles northeast of Elk City, OK. Timber and grass. Minimal fire behavior with smoldering. Reduction in acreage due to more accurate mapping.

Lake Pasture, Texas A&M Forest Service. Started on private land 27 miles south of Victoria, TX. Hardwood litter. Minimal fire behavior.

344, Florida Forest Service. Seven miles east of Florida City, FL. Grass. Moderate fire behavior with flanking. Last report unless significant activity occurs.

Walker Mission Ridge Drive, Georgia Forestry Commission. Started on private land one mile west of White Oak, GA. Hardwood litter and timber. Minimal fire behavior with smoldering. Structures threatened. Precipitation occurred over the fire area yesterday. Last report unless significant activity occurs.

Cumulative acres showing in the Active Incident Resource Summary Table may not be reflected in the YTD statistics due to a lag in units completing YTD adjustments in the SIT/209 Application. Otherwise, changes in agency YTD fires and acres reflect more accurate mapping or reporting adjustments.

Predictive Services Discussion:

Widespread elevated to critical conditions are forecast today across much of the central and southern Plains into the western Mid-Mississippi Valley. South to southwest sustained winds of 15-30 mph with gusts 30-40 mph are forecast amid minimum relative humidity of 5-20%, lowest in the southern Plains. Breezy and dry northwesterly winds amid relative humidity of 15-30% will develop in the Southeast today, as well, but recent precipitation will mitigate conditions. However, elevated to critical conditions are expected across the southern half of Florida where little precipitation has fallen. A Pacific storm will continue moving through the Intermountain West, with the bulk of the precipitation from the Sierra through the Great Basin into the northern and central Rockies as heavy snow falls in the mountains. Breezy westerly winds are also likely in much of the Great Basin to the Southwest, west of the Divide, but high relative humidity and ongoing or recent precipitation will mitigate the conditions.
