Predictive Services Discussion:

A strong surface low-pressure will form over western Kansas tomorrow and move into lowa overnight. Widespread critical to extremely critical conditions are forecast from eastern New Mexico and southeast Colorado into West Texas, western Oklahoma, and western Kansas. Southwest winds of 25-45 mph with gusts of 40-65 mph are forecast amid relative humidity of 5-15% with well above normal temperatures. Winds and low relative humidity are likely to continue overnight in eastern New Mexico to West Texas into western Oklahoma, where burn periods may continue into Wednesday morning. Farther to the East, south to southwest winds of 20-30 mph and gusts to 40 mph are forecast from central Texas into the Mid-Mississippi Valley but relative humidity is expected to be higher and 20-35%.

Much of the Appalachians to the East Coast will be dry with very low minimum relative humidity of 10-25% expected, although winds overall will be light. However, locally gusty westerly winds are possible in portions of West Virginia into central and western Virginia creating locally elevated conditions. Precipitation is expected to spread across the central and northern Plains into the Midwest north of the surface low, with mixed precipitation and snow from Wyoming and northeast Colorado into central Minnesota. In the West, precipitation will gradually end in the Great Basin, but heavy snow is likely to continue in the central Rockies.
