Predictive Services Discussion:

Breezy and dry northwesterly winds of 15-30 mph with gusts to 40 mph are expected across much of the central and southern Plains. Very low relative humidity of 3-15% is expected in central and South Texas creating critical fire weather conditions, but higher humidity above 20% is forecast from Oklahoma into Nebraska. Elevated to locally critical conditions are also forecast from the Piedmont into the Upper Ohio Valley where southerly winds of 10-20 mph will combine with minimum relative humidity of 7-20%. Low humidity will continue in the rest of the Southeast and Florida, as well. Farther west, very dry conditions are likely in the lower elevations of the Southwest although winds are expected to remain light.

A strong spring storm will move through the Midwest with blizzard conditions likely for northern Iowa and southern Minnesota through much of Wisconsin to the Upper Peninsula of Michigan. Scattered showers and thunderstorms will develop along the cold front from the Lower Peninsula of Michigan south to the Tennessee Valley, with the best chance for wetting rain north of the Ohio River. A storm will move into the Pacific Northwest today and tonight, with moderate valley rain and mountain snow.
