Predictive Services Discussion:

Breezy and dry southwest winds of 15-30 mph with gusts to 45 mph amid minimum relative humidity of 8-25% will develop across much of the central and southern High Plains into southeast North Dakota. Widespread elevated fire weather conditions are expected, with critical conditions most likely in eastern New Mexico. Critical conditions are also forecast for the eastern half of the Florida peninsula where southwest winds 15-20 mph gusting to 30 mph will combine with minimum relative humidity as low as 20%. Elevated conditions are forecast along the northwest Gulf Coast where northwest winds of 10-20 mph combine with minimum relative humidity of 15-25%, as well.

A cold front will move off the East Coast today, with scattered light precipitation, heaviest in the Northeast, while many areas in the southern Appalachians and Southeast receive little to no rainfall. A storm will continue to move through the northern half of the West with valley rain and mountain snow, heaviest along the coast and in the Cascades. Above normal temperatures and generally dry conditions are expected across Alaska, while breezy trade winds and light windward showers occur in Hawai'i.
