Hardwood litter, light slash and timber. Active fire behavior with uphill runs, running and flanking. Numerous structures threatened. Area, road and trail closures in effect.

Deep Woods, North Carolina Forest Service. Four miles northeast of Saluda, NC. Hardwood litter, timber and light slash. Active fire behavior with uphill runs, running and flanking. Numerous structures and communication infrastructure threatened. Area, road and trail closures in effect.

Fish Hook, North Carolina Forest Service. Five miles north of Columbus, NC. Hardwood litter, timber and light slash. Moderate fire behavior with backing, creeping and smoldering. Structures threatened. Area, road and trail closures in effect.

Table Rock Complex (2 fires), South Carolina Forestry Commission. CIMT (SA Team 2) mobilizing. Four miles northeast of Sunset, SC. Timber, hardwood litter and heavy slash. Active fire behavior with running, spotting and flanking. Numerous structures threatened. Evacuations, area and trail closures in effect.

Predictive Services Discussion:

Dry and breezy northwesterly sustained winds of 12-25 mph with gusts to 35 mph amid minimum relative humidity of 10-25% will develop in the Appalachians to the southeast Atlantic Coast creating elevated to critical conditions. Breezy northwesterly winds are also expected in the Northeast, but humidity will be higher. In the Plains, southerly winds of 10-20 mph are expected, but relative humidity is forecast to remain near or above 20%. In South Texas, a significant increase in moisture is expected with widespread showers and thunderstorms and areas of heavy rain, while scattered showers and thunderstorms develop near the Red River. Well above normal temperatures are expected today across the West, with low relative humidity in the single digits and teens from the Mojave Desert into New Mexico and Colorado, west of the Divide. Enough moisture is also forecast to be present near and east of the Divide in New Mexico for isolated dry thunderstorms in the afternoon. In the Northwest, a cold front will move onshore with scattered showers and thunderstorms, with some severe thunderstorms likely from the Coast Range to the Cascades. Temperatures in Alaska are likely to remain near to above normal, while light snow develops over the central Interior tonight. Light southeasterly trade winds are expected across Hawai'i, with a few showers, most numerous over the Big Island.
