

**PROHIBITED ITEMS IN ACCORDANCE WITH FAA & TSA REGULATIONS ON SIERRA PACIFIC AIRLINES:**

1. Transportation of explosives aboard aircraft.
2. Possession or use of narcotic drugs including marijuana aboard aircraft.
3. Interference with flight crew members.
4. Conveyance of false information concerning illegal carry-on items.
5. Switchblade knives, K-bars, brass knuckles & pointed scissors unless in cargo hold.
6. Incendiary devices such as flares and fireworks. (FUSEES)
7. Strike anywhere matches, lighter refills, lighter fluid and torch lighters.
8. Loose ammo, loaded firearms without authorization, black powder, primers and percussion caps.
9. Heat producing devices containing batteries, butane and propane.
10. Removed, loose or spare batteries must be protected from short circuit, don't allow battery terminals to touch other metal. Removed or spare lithium batteries must be carried in carry on.
11. No spare lithium metal or ion batteries in checked baggage.
12. Devices with batteries installed but no protection from accidental activation such as vaping devices must be in carry-on bags.
13. Equipment that still has fuel in it, including residue or vapors (includes portable fuel bottles).
14. Military-issued weapons must have the bolt in the open position & flag safety device inserted in the camber of the weapon. Removal of the bolt is allowed. All magazines must be removed & bayonets stored in the cargo hold.
15. Flameless Ration heaters CANNOT be opened or used to heat MRE's during flight.

Devices containing lithium metal or lithium ion batteries (laptops, smartphones, tablets, etc.) should be transported in carry-on baggage and not placed in checked baggage. When this is not possible, the devices should be completely powered down to the OFF position (they should not be left in sleep mode), protected from accidental activation, and packed so they are protected from damage.

This list is not all inclusive and a full list of hazardous material items 49 CFR 175.10 should be consulted.
